Candidates themselves may not use the letters to the editor column to outline their views and platforms or to ask for votes; this constitutes paid political advertising.

As with all letters and advertising content, the newspaper, at the sole discretion of the publisher, general manager and editor, reserves the right to reject any letter that doesn't follow the above criteria.

decision — not by relying on spoon-fed rhetoric,


headlines, carefully staged interviews, rants on social media or even some of the news sources that claim to be unbiased.
