Cottage Grove Ranger Station move to be complete by Nov. 30

The office for the Cottage Grove Ranger District will begin its moved three miles southeast to a new office on the Dorena Genetic Resource Center grounds during the week of Nov. 26, with an estimated completion date of Nov. 30.

The new address will be: 34963 Shoreview Drive, Cottage Grove, OR 97424. The phone 541-767-5000, will remain.

The agency will continue to lease warehouse space at the current location until final construction is complete at the new site in order to meet the facility needs of the

ranger district's wildland fire fighting module.

The change in office location from a leased facility to an owned facility is a cost-saving measure.

"This move will save the District a great deal of money as it reduces leasing costs. The overall size of our organization has downsized over the past years, and now we simply require less space," said District Ranger K.C. Briggs, who added that it will also allow placement of resources into other needed programs.
