Reminder: Tax filing deadline postponed until May 17

With April 15 today, the Department of Revenue reminds taxpayers that the deadline for filing individual income tax returns for the 2020 tax year has been postponed to May 17.

The IRS and Oregon both announced the postponements last month.

Individual taxpayers, including those who pay self-employment tax, can also postpone state income tax payments due on their 2020 tax year return until May 17.

Individual taxpayers will automatically avoid interest and penalties as long as they pay all taxes due by the postponed deadline. Penalties and interest will begin

Oregon has not postponed the due date for first-quarter estimated income tax payments for 2021. Estimated tax payments are still due April 15. Taxpayers may choose to pay directly from their bank account or by credit card using Revenue Online.

Oregon taxpayers, who received unemployment in 2020 and have not yet filed their tax returns, can do so now following the instructions the IRS recently provided. Most e-file software providers have indicated they have the necessary software updates in place.

Taxpayers should check with their tax preparer or software provider if they have questions about the updates.
