

Douglas County Reminder: Third Trimester Taxes Due by May 17

ROSEBURG — The Douglas County Tax Collection Office would like to remind residents that the deadline for the third trimester payment for the 2020/2021 Property Tax year is fast approaching. The third trimester payment must be received or postmarked no later than Monday, May 17 to avoid interest and penalties.

Here are a few Important Reminders from the Douglas County Tax Collection Office:

- Make payments utilizing one several options: While the tax office is open to the public and staff is available to assist residents, for everyone's safety residents are encouraged to make their payments utilizing one of our many contact-free options. Residents that need additional help can conduct business with the office via phone, email, online or in-person. Staff can assist residents between 8 a.m. and 5 p.m.,

Monday through Friday. Note that offices are closed during the lunch hour from noon to 1 p.m.

Payments can be placed in our drop boxes:

Place payment in one of several drop boxes located at the front of the Douglas County Courthouse (at the base of the steps) or in the hallway outside the Douglas County Tax Collection Office. The Douglas County Courthouse is located at 1036 SE Douglas Avenue in Roseburg. Do not place cash in the drop box. Convert all cash payments to a cashier's check, money order or personal check.

Payments can be made via U.S. Mail:

Mail tax payments using the provided payment envelope and appropriate postage for the quickest processing. Do not send cash; convert all cash payments to a cashier's check, money order or personal check. Due to recent changes with the U.S. Postal Service, mail is often transported out-of-town for processing and postmark. Be sure to mail tax payments early or take the payment envelope into the post office to receive an official "hand stamped local postmark" to avoid late penalties.

Payments can be made online:

Payments can be made on-line at www.co.douglas.or.us using a credit/debit card or e-check. If payment is made using the online method, there will be a 2.49 percent transaction fee for credit cards, a \$3.95 transaction fee for

debit cards and a \$3 transaction fee for e-checks. There is a public computer with internet access, located in the Douglas County Tax Collection Office lobby, allowing taxpayers to make their online payment.

Payments can be made in person at:

Douglas County Tax Collection Office located in Room 205, at the Douglas County Courthouse, 1036 SE Douglas Ave. in Roseburg. Important reminder: Due to changes in corporate guidelines, the Reedsport Branch of Umpqua Bank is no longer accepting property tax payments from Douglas County residents. Property tax payments for all county residents will need to be made via our drop boxes, by mail, online or in-person at the Douglas County Tax Collection Office in Roseburg.

The City of Cottage Grove is developing a Transit Development Plan to help guide the future of public transportation in and around Cottage Grove, including the City of Creswell.

The City of Cottage Grove is now looking for community input on the draft plan and invites your review and feedback.

The draft plan can be accessed on the project's website and will be open until Monday, May 10, 2021. The Cottage Grove City Council is set to review and make a motion on the final draft plan in June 2021.

Public transportation is any transportation that is available to the public, including the bus, Dial-A-Ride, Mobility on Demand (MOD), bike share, and more.

The plan will define the role of public transportation in the Cottage Grove area, identify public transportation needs based upon community and stakeholder feedback,

and guide public transportation's response to area needs.
