Vegetation that is: A health hazard. A fire hazard because it

is near other combustibles, or A traffic hazard because it impairs the view of a public thor-

oughfare or otherwise makes use of the thoroughfare hazardous.

As used in sections 6.015 to 6.025, the term "obnoxious vegetation" includes:

Weeds more than 10 (a) inches high. Grass more than 10 inch-

es high and not within the exception stated in subsection (1) of this section. Except as section 6.020 provides to the contrary, no owner or person in charge of property may allow obnoxious vegetation to be on the property or in the right of way of a public thoroughfare abutting on the property. Obnoxious vegetation so

located is a public nuisance. In accordance with sections 6.800 to 6.830:

(a) The city may abate the nuisance; and
