is that a rigid investigation will be made, and while the outcome is, of course, uncertain, the representative from Oregon believes emphatically that the railroad company will be compelled to live up to the terms of the grant.

In this event about 3,000,000 acres of land will be placed on the market at \$2.50 per acre, the price fixed when the grant was made. A large body of agricultural and mining lands will be opened to settlers at a low price, a fact which will prove a strong impetus to the heavy immigration headed for the coast.

"There is no question but that the Lewis and Clark exposition accomplished an inestimable good for this state," said Mr. Hawley. "It is evidenced on every side throughout the east, and while I came in contact with only a small part of it, nevertheless there came to me from every source words and music sounding the praises of the Oregon country."

"That there is a tremendous movement in this direction is more clearly evidenced by the strenuous efforts being made by the railroads to corner the western traffic as much as possible. The roads are not only advertising the state extensively, but they are seeing to it that the trade thus originated is diverted over their particular lines."

**OREGON GIRLS IN JAMESTOWN**

A Company of Handsome Oregon Girls Will be Sent to the Jamestown Exposition.

A company of handsome Oregon girls will be sent to the Jamestown exposition, starting from McMinnville. The scheme was originated by J. C. Cooper, the celebrated author of "The Yambills."

The company will assemble about the 8th of July for a month's drill and training, which will consist of physical and military drill and manual of arms so far as the same may be exemplified with six foot spears, Indian dances and chants in rich Indian costume, fire and ghost dances at night around and thru a blaze of colored fire. Many of the girls are good riders, and where opportunity offers, will show their ability to handle a horse and throw a lasso.

On all occasions when not in their Indian drill, the girls may be distinguished by their uniform dress and cowboy hat with "Oregon" printed in gold on a red leather band. Their drill costume will consist of light buckskin-colored broadcloth cravenette, richly trimmed with beads and buckskin fringe, with a beaver heads design stitched on the pocket. The city of McMinnville will entertain the girls free during their month's training and contribute liberally toward the expense of the enterprise. The company will start East early in August and will be absent from the state six or eight weeks, if the present program is carried out. The company will create great enthusiasm wherever they go. Miss Belle VanDuyn of Eugene, has been selected to represent Lane county.

**Men Who Swear Are Ignorant.**

Profanity is the object of a vigorous crusade that is being waged in the East. Newspapers all over the continent have taken up the cudgel and have been dealing body blows at "cuss words" in general. The Bishop of Carlisle lately made the topic a subject for a sermon in which he said in part:

"Anyone who swears discloses the weakness of his vocabulary. He does not know the possibilities of the English language, or has not the skill to manipulate it so that it will yield the amount of fire he

wants. You can do almost anything with common words.

"Words can do things that make the ordinary bits of profanity look like feeble scarecrows stiffened up with a fence stake. The cure for profanity is merely wit enough to handle your words so that swearing will seem like baby talk in comparison. Profanity is an evidence that the swearer, no matter how well educated he may be in other lines, is still sadly lacking in the knowledge of the English language."

**Tacoma Jarred by Earthquake.**

Tacoma, Wash., March 29.—A sharp earthquake shock occurred at 7:05 o'clock this morning. News from the suburbs shows that the earth tremors were felt generally within a radius of 15 miles of the city.

There were two distinct shocks, the first being the more severe, the second following about 10 seconds later.

The shocks were in the form of a wave-like motion from the southeast to the northwest, and on this account the disturbance is attributed to some seismic trouble in Mount Rainier. Many people claim to have heard a rumbling noise, which was not noticed by others.

The shocks caused considerable fright in hotels and large buildings, which rocked perceptibly.
