**NOMINATIONS FOR OFFICE.**

Usually the citizens of Cottage Grove have but two tickets in the field from which to select the officers to govern the city's affairs for the municipal year.

This time however, they are more fortunate or otherwise, as one may look at it, in having three tickets presented for their consideration.

The first ticket named is headed by Oliver Veatch for mayor and A. H. King for recorder. Mr. Oliver Veatch has been for some time past one of the city council, but his term will expire the 3rd of April. Mr. Veatch states he was not an aspirant for the nomination and consented to accept, only by the urgent request of his friends. He has stated publicly that if elected he will give the city his best effort and will so far as possible, with due regard to the city's financial condition favor all public improvements and will insist upon the enforcement of the laws as they now stand; believing them to be sufficient without any additions, or at least until changed by the vote of the people.

Mr. King is a lawyer in the city and is well known. Both he and Mr. Veatch have signed the platform as adopted by those who placed them in nomination and printed in another part of this number under the head of the Law and Order ticket.

The second ticket is headed by Thos. K. Campbell, president of the Pacific Timber Company with headquarters in the city. He received his nomination from a meeting of the members of the Commercial Club and business men. Mr. Campbell was not desirous of accepting, but consented to make the race, after his nomination. He is at present a member of the council, having been chosen by the board to fill the vacancy occasioned by the resignation of Dr. Wall.

Mr. Campbell believes that there are some things needed to make the city what it should be. Is in favor of an enlargement of the present water supply and if elected will also favor such improvements as the financial conditions of the city will justify.

F. H. Roseburg, candidate for recorder is well known in the city having been book-keeper and auditor for the Pacific Timber Company for years and is an expert accountant.

The ticket upon which their names are placed is designated the Business Men's ticket. The candidates for treasurer and councilmen are the same as on the Law and Order ticket they having been endorsed by those who placed the Business Men's ticket in nomination. The platform of this ticket is also printed in this issue.

Wm. Hogate, F. D. Wheeler and Marion Veatch the nominees for alderman on both these tickets are well known citizens and will no doubt do their part in conducting the affairs of the city in a satisfactory manner.

That, called the Citizen's ticket was nominated by a meeting of citizens held in the Opera. The nominations are as follows: For mayor R. M. Veatch, recorder J. E. Young, aldermen James Barret, J. H. Bartels and W. C. Johnson. So far as learned there has been no platform adopted or written statements made by or for this ticket.

**NO ILLEGAL VOTING.**

Those who have been instrumental in placing the Law and Order and the Business Men's ticket in the field decided at their meetings on Monday night, that so far as in their power to prevent it, there will be no illegal voting at this city election.

Men have been appointed to learn as far as possible the names of those who are entitled to vote and to remain at the polls and watch carefully for fraudulent votes.

This is a step in the right direction.

that may be made during the coming year; should be effected by careful and painstaking legislation, bearing in mind that we are already burdened with high taxes, that our pledges must be kept, and that a month is an abnormal amount to expend. While we recognize the necessity of maintaining police authority, we feel that other duties should be performed by the day police, other than a disinterested parade of the streets and the collection of the water rents. It will do a blue uniform no harm to be laid aside occasionally, that the wearer pay day is forthcoming. In view of any improvements that shall be deemed necessary, we further admonish that the authorities should keep a well-trained eye upon the expense account of the city. That every dollar should be made to do a dollar's worth of work, faithfully and well.

**Police System**

SEC. 7.—We believe, for the services rendered, that \$120.00 per month may get some needed exercise in an effort to scrape some of the mud from the cross-walks that pedestrians may cross without danger of miring down.

**Fire Protection Encouraged**

SEC. 8.—We wish to compliment the fire department of this city. Every member has a reputation for prompt reply to the fire summons. But too little thought is given the boys who in the most part take the brunt of the work, when the department is called into service. It would appear to us that the needs of the fire boys should be looked into more carefully, and a little encouragement extended for past favors, and looking to their future interest.

**Municipal Ownership**

SEC. 9.—We believe in municipal ownership of any legitimate system that will increase the revenues of the city. In this belief we feel that the time is now at hand when we should discuss, and if practicable, put into operation, a plan whereby the city may secure control of an electric light plant. With our own water system and electric light plant, it would appear, that the burden of the city's expenses would be cut off. As an illustration, we would respectfully refer to the revenues of the present water system now owned and operated by the city, without which revenues the city would today be in straightened circumstances. It is a question that demands the most conservative attention, and one worthy of our best efforts. Therefore, we are in favor of taking this matter up at an early date, and give it the careful attention it deserves.

**Gambling**

SEC. 10.—We believe in the enforcement of the laws regarding gambling. It is unlawful. Therefore, the thing to do is to (1) obey the law. (2) Enforce the law.

**Card Rooms**

SEC. 11.—It is known that, with one exception, card rooms are run in the rear rooms of the several cigar stores in the city. There is nothing to prohibit one from opening a resort of this kind, neither can we prohibit card playing in the main. But there should be a law prohibiting boys under the age of eighteen frequenting such resorts. In so doing the interests of the proprietor and the boys are protected, and the heart of the anxious mother is made lighter.

**Curfew**

SEC. 12.—We believe in the time-honored Curfew law. We believe that, not only should the ringing of the bell be executed, but that the law should be enforced. It is an ordinance of this city—has been in force for many years; but it appears to us that it is a law in name only. If it is worth space on the ordinance record of this city, why not enforce it?

**Final**

In presenting this platform, we wish to say that we stand in the open for good government; good people and good laws, and the enforcement of good laws. We ask for the good offices of every honest citizen who is willing to lay upon the altar of good government an honest vote.
