The publishers would like to call your attention to the increased amount of local news appearing in the Leader which will be made a feature hereafter.

It is the duty of every American citizen and the great pleasure of every boy and girl to celebrate the 4th of July. We all should show our appreciation to the brave men who, in 1776 made it possible for us to live in a country like the United States—the greatest of all countries.

This agitation for unrestricted Chinese immigration should be set down on hard by the people. Keep the Asiatic borders out of America—Chinese and Japanese alike—and the yellow peril may never blight the peace and prosperity of this country. Better sell a few sacks of flour less in China and preserve the independence and intelligence of our laboring people.

Notwithstanding that he is a skillful engineer, the government is well rid of John E. Wallace, who has resigned his position as chief engineer of the Panama Canal because he was not allowed to have supreme authority in directing canal affairs generally. When a man becomes imbued with the idea that he knows more than the man next above him, and is better qualified to boss things, then is a good time to accept his resignation.

It is to be hoped that one of the reforms which may grow out of the committee which the president has appointed to investigate the business methods of the federal departments will be a single purchasing division which shall be charged with the duty of buying all government supplies. Such a division under the supervision of a competent head would save the government millions of dollars every year. Recent investigations conducted by newspaper men show that some departments of the government pay double as much for the same supplies as is paid by others. Moreover the purchase of supplies in larger quantities would enable the sellers to make lower rates than they can where they are compelled to engage in a dozen transactions for the disposal of an equal amount of merchandise.

Washington June 28—Secretary Metcalf of the department of commerce and labor will, it is asserted, throw up his job as a cabinet officer when the summer wanes, because of the summary directions given him by the president to issue orders to his subordinates to deal leniently with the Chinese. It is asserted that Metcalf did not issue the order without showing the president plainly that he did not wish to do so because he felt the situation one that should be dealt with in another way. Metcalf comes from California and is in favor of Chinese exclusion. He probably is the best equipped man in the cabinet to talk on the subject.

Secretary Taft, to whom the question was referred for quasi administrative advice, took the position that Metcalf being a Californian was prejudiced against the Chinese beyond the point where advice would be accepted as safe and sane.

The general opinion in Washington is that as he has permitted this faux pas to occur the president has been guilty of discourtesy to the secretary of commerce and labor. For these reasons Metcalf was on the point of tendering his resignation to the president the moment he was ordered to promulgate the instructions June 24. Friends however, kept him from handing in his resignation.

The order to accept as bona fide a certificate presented by any Chinese without the usual tests to find out if the person to who it is issued is entitled to it, it is pointed out is but the opening of a wide door for wrong-doing.

Said Roosevelt Was "The Freshest".

President Roosevelt was given the greatest rebuff of his life by a woman of the backwoods of Albarmarle, who did not know she was speaking to the head of the Nation. Few heard it, and it is likely the story would never have become circulated had it not been told by Mr. Roosevelt himself, who laughed immoderately about the incident. It occurred at Red Hill, Albarmarle county, a little station on the Southern Railway, where the President left the train to go to the country home near Scottsville recently purchased by Mrs. Roosevelt. According to his usual manner the President stopped to shake hands with the crew of the train. Just at that time he noticed a plainly dressed elderly lady attempting to get on the car. Rushing forward Mr. Roosevelt assisted her to ascend the step, he then caught her hand and gave it a regular "executive" shake. The President was dressed in a rough and ready costume and the woman had no idea who he was. Snapping her hand away and eyeing him wrathfully, she said: "Young man, I don't know who you are and I don't care a cent. But I must say you are freshest somebody I've seen in these parts. She then entered the car and the President passed away convulsed with laughter.

Court Notes.

In the state of the State vs. Geo. L. Stidham, charged with illegal voting at the Cottage Grove city election last April, the demurrer to the indictment was sustained and the case resubmitted to the grand jury.
