George Martin Hull.

George Martin Hull was born in Columbiana County, Ohio, Sept. 23, 1829, and died Sept. 25, 1905, at the age of 78 years, at the home of his son John H. Hull about two and a half miles south of Cottage Grove on the Coast Fork of the Willamette.

He was born and raised a farmer, but taught school many years planting in youthful minds solid foundation for many usefulness and good citizenship, and thus qualifying them for active duties of life. He was county surveyor and county assessor. In 1861, he joined the state militia at Grant City, Mo., under Captain J. F. Mason, and thus became a defender of his country in troublous times.

He was married to Mary Jane Denison Nov. 25, 1852. In 1856 they moved to Missouri, where his wife died in 1881.

Mr. Hull was the father of seven children, three girls and four boys, only three of whom survive him. John H. of Oregon; U. G. of Washington, and Annie F. Smiddy, of Missouri.

After living in Missouri twenty seven years, Mr. Hull went to Florida, and then to Illinois, from whence he came to Cottage Grove in 1891, and lived near here until death called him to the unseen world. He died of stomach trouble.

In his younger years, he took a prominent part in political affairs

at a time when courage and firmness were needed to maintain right. Inscribed upon his banner were the impenetrable principles of Freedom, and a united country forever. He was a kind and loving husband, an indulgent father, and an honored and respected neighbor.

In loving remembrance we bid him farewell.

Burned to Death.

Herman Hoil Ellison, infant son of Mr. and Mrs. Frank Ellison, was burned to death at their home southeast of Cottage Grove, Sept. 14, 1905. The little one was playing in the yard and had gone out side where there was a small bon fire, and thinking to put it out he stomped it as he no doubt had seen others do and this started fresh flames which caught in his dress burning him badly under the arm and it is thought he inhaled the flames as in half an hour the dear little one was dead, before the doctor arrived.
