Game Law Arrests for the Last Two Weeks.

Eugene.—George Dinehart, a resident of Eugene, married and aged about 50 years, was this afternoon examined before County Judge Chrisman for insanity and committed to the insane asylum. Drs. J. W. Harris and Geo. O'B DeBar were the examining physicians.

It appears that Dinehart drove to Cottage Grove and began to act strangely while there. He returned to Eugene on this morning's train, and his folks at once noticed that something was wrong. He said he did not know where he left his team and declared that some one was after him to do him bodily harm.

He will be taken to the asylum at Salem tomorrow.

Roseburg's City Election.

Roseburg, Ore.—In a hotly contested election held in this city yesterday. Dr. E. V. Hoover was re-elected mayor by a majority of 51. Mr. Hoover is about 30 years of age and was born and raised in Roseburg. The town voted to take off the lid and knocked out the local prohibition law.
