Cottage Grove and Lane County should see that they get a good representation in the \$40,000 advertising book that the Portland Chamber of Commerce is getting out to advertise the state.

Chas. A. Johns is making a strong race for the governorship. He is a business man, and a successful one at that, and should be able to give a first class business administration. He makes a strong plea for the support of the people and will certainly stand at the head.

The western railroads are taking up the matter of publishing the movement to "see America first," and will unite in concerted action to forward the work. The east is trying to get off a good deal of cheap talk about the idea, but it falls rather flat. Undoubtedly the movement will work out to greatly help the west.

S. B. Huston, candidate for the republican nomination for congress, was a visitor in the Grove on Friday and will return next week to be present at the Farmers' and Dairy-men's Convention. He is making a strong fight on the question of rate legislation, and is bringing the people to understand that he intends to support any such legislation.

A published estimate, based on the statements of manufacturers, places the number of automobiles in use in this country at 100,000. In other words, one person out of 800, one family in less than 200 operates one of these machines. There were seven times as many automobiles made in 1905 as grand pianos in the last year for which figures are at hand. There are now about four-fifths as many automobile owners in this country as there are lawyers or clergymen, engineers or firemen, plumbers or butchers. The automobiles actually outnumber the bar-tenders of America.

Development League for Umatilla County.

Pendleton, Or., Feb. 11.—A movement to organize a Umatilla county Commercial Club or Development League, to be composed of all the commercial organizations in the county, is now being promoted.

So far as canvassed, the commercial bodies of Adams, Weston, Arbena, Echo, Milton and Helix are willing to co-operate with the Pendleton Commercial Association in the formation of a Umatilla County Development League, which may ultimately develop into a Columbia River Basin Development League, comprising all the commercial bodies in Eastern Oregon and Washington, with Pendleton the central body in the organization.

The Farmers' and Miners' Telephone Association.

This association was recently formed by a number of the farmers along the O. & S. E. railroad and the miners of the Bohemia District, and commencing with this week they are making plans for the immediate construction of their line. Every farmer, along the proposed line, that desires a phone will build his own line to connect with the main line. The main line will be constructed by a pro rata charge against each phone used, which it is estimated will be not over \$25 per phone for first cost of construction. The phones will be rented from the Pacific States Tel. & Tel. Co. for fifty cents per month, payable semi-annually in advance, the Pacific States keeping the phones in repair; the Association keeping the line in shape. The charges for maintenance will probably be more than kept up by the tolls from persons who are not subscribers.

The subscribers will all be connected with the Cottage Grove central station, will have twn connections, and toll service to any long distance point, with all suburban service free.

The line to be constructed will be a four wire metallic circuit to the Red Bridge and from there up Sharps Creek, and the Hardscrabble road into the district, it will be a two wire metallic circuit, and will furnish the best of service. A great many have agreed to sign up and many have already done so. The line will be started at once, and completed as far as Mineral, and as soon as the snow goes the line will be extended through the camp.

If a new subscriber wishes to come in after the line is completed, he will be allowed to do so by paying the regular pro rata charge, which the other subscribers paid, and the amount will be either laid in the treasury for maintenance, or paid back to the subscribers in dividends.

All parties along the line are looked for as members and a good line will be had. Anyone wishing to get on the line can get full information from the Cottage Grove agent of the Pacific States Telephone Co.

DIED

Another pioneer has gone to his long rest. "Uncle Jack" Knowlton, a resident of Cottage Grove for some 33 year died Monday morning after a sickness extending over a period of some two or three years.

Porter Davis Knowlton was born September 26, 1826 at Chicopee Falls, Hampden County, Mass. He crossed the plains with an ox team in 1850 for California, moving to Oregon in 1873. He was married in Yamhill County to Sarah J. Martin, Jan. 9th, 1873, coming to Cottage Grove in December of the same year and has resided here ever since.

He leaves besides a loving wife, the following children: L. D. Knowlton of Portland, Mrs. H. G. Morris of Eugene, Mrs. Fingal Hinds, Mrs. Orvel Knapp H. S. Knowlton and Katie Knowlton of this city, besides many friends.

The funeral services were held from the family residence and were conducted by Rev. J. H. Sharp, assisted by Rev. C. H. Wallace, both old pioneer comrades, all nearly eighty years old, whose ministrations were especially tender in that "Uncle Jack" had been converted through the ministrations of Rev. Sharp only a few days before his death. The body was laid to rest in the McFarland cemetery.

Kicked and Dragged by a Horse.

J. J. Moore, butcher for B. F. Goodpasture, was quite severely but not seriously injured yesterday afternoon about five o'clock by being kicked and dragged on the ground by a horse. Mr. Moore was riding his horse along East Fourteenth street when in going over a crosswalk the horse slipped and fell, Mr. Moore being underneath. His foot became entangled in the stirrup, and when the horse arose it started to kick and run, dragging the rider on the ground for a considerable distance and kicking him on the left side of his head near the eye, inflicting a bad wound. The horse ran into the Chessman yard, where Mr. Moore succeeded in extricating himself. Besides the injury on his head he has numerous scratches and bruises on all parts of his body.

A Pucky Little Fellow.

Herbert Mosby was leading a horse the first of the week, and had the rope wound around his hand. The horse began to pull back but the boy hung on until his left elbow was dislocated, as well as two fingers. The members have been reset and he is getting along nicely.

28,000 Loaded Shells.

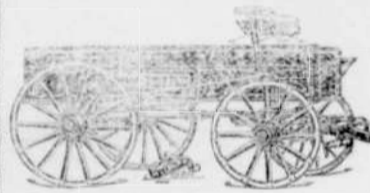
