Brick Finally Arrive.

Council Has Special Meeting.

At a special meeting of the council on Monday night a special ordinance fixing a yearly license for the Opera House was brought up but was laid over for one week.

S. V. Allison obtained permission from the council to make a number of alterations in his building occupied by Comer's harness shop, extending the rear of the shop so as to give room for a sky light.

The council ordered warrants drawn of \$1.50 apiece to each of the nine clerks and judges at the last election, also \$4.50 for rent and fire wood for voting places.

In view of the non-repair of several street crossings by the street commissioner, charges were preferred against him, and he will be removed at the next council meeting.

Marshal Underwood was instructed to keep the street crossings clean during bad weather.

An Appeal From the Boys' and Girls' Aid Society.

To the friends of dependent children

A little over 21 years ago a few of our representative citizens saw the great need of some organization for the care and protection of dependent children and also to aid children who had committed their first offense against the laws, hence the organization of the Boys' and Girls' Aid Society of Oregon. At that time it was a charitable organization; dependent entirely upon the generosity of the public for its support. Since that time, however, it has grown rapidly and its work has commended itself to the charitable public and to the state officials and to-day it is not only assisted by private subscriptions but by state and county appropriations. It is, however, conducted on a very economical basis, and its expenditures each year do not exceed \$10,000. Its methods are to place dependent and neglected children in family homes where they will receive a parents care and attention, and in order to insure this visitors are kept on the road the entire time, and besides which at this time there is organized at many of the County Seats an Advisory board composed of representative citizens who assist the Society in its work of aid and supervision over its wards placed out in homes. In this county Mrs. Laura Lowe is president and J. M. Williams, Attorney, is Secretary.

From January 1st to November 1st, 1906, a period of ten months, the Society has received 326 children or an average of about 32 per month. These children were received from the following counties: Baker, Benton, Clackamas, Clatsop, Crook, Douglas, Grant, Lane, Marion, Multnomah, Umatilla, Union, Wasco, Washington, Wallowa and Yamhill.

Many of the children committed have indeed sad histories. In a very recent case from an outside county a terribly immoral and depraved condition of parental care was unearthed. Five children were living alone with their father in extreme filth, poverty and vice. The oldest of this number was a boy of 14 and the youngest a baby of about 16 months. The second in age was a girl aged 13 and the next a girl of about 11. It was reported by ladies of the vicinity to the Superintendent of the Society that the two girls had complained to them that their father was behaving in an immoral and inhuman manner toward them. After an investigation by the Superintendent the father was arrested and the children awarded to this Society; the baby, however, going to the Baby Home. The inhuman father is now awaiting his trial in the county jail. Some of the children have already found desirable homes and seem pleased with their new surroundings.

A short time ago a family was committed to the Boys' & Girls' Aid Society through the Juvenile Court of Multnomah County. This family consisted of six children. The parents were bringing the family up in idleness and vice. The father utterly refused to work and the mother was mentally irresponsible. The family had been charges on the County for many years. At one time they were sent at the expense of the County to relatives in Kansas, but the authorities there immediately returned them to Oregon. It was necessary that some measure should be taken to break up the family for the sake of the children. Therefore, officers went to the house and took charge of the entire family. The children were sent to the Boys' and Girls' Aid Society, the father to jail and the mother to the poor farm. Most of these children are somewhat feeble minded and they may be for a long time charges of the state. Thus, every child that is committed to the care of the Society has a sad history and if there is any worthy cause for charity the Boys' and Girls' Aid Society should certainly appeal to every person who has the welfare of little children at heart.

The public schools throughout the state have heretofore been of great assistance and it is sincerely hoped that they will do their best this year. In addition to this, any person who will send in a trifle in money, provisions, vegetables, or fact anything and everything that would be useful in a household, will receive the gratitude of the management.

The railroad and steamboat companies running into Portland have kindly consented to carry all donations at Thanksgiving time free of charge addressed to the Boys' and Girls' Aid Society, Portland, Oregon.
