George M. Cornwall, publisher of the Timberman, the best timber publication on the coast, was in Cottage Grove Wednesday, on his way home from a trip among the mills of Southern and Western Oregon. Mr. Cornwall is taking great interest in the proposed amendment to the interstate commerce law, as published in this issue, in which shippers should have a hearing when there is a proposed change in freight rates.

We also publish on first page an article from the Saturday Evening Post, regarding the railroad laws which have been in operation in Canada for several years, a similar one which is now sought to be put in effect in the United States, and it is along that line that Mr. Cornwall is working. We believe a law of this kind would not only have an effect toward lessening the present unpopular feeling towards the railroads, but be a protection to the shipper as well.

The acquittal of United States Senator Borah, of Idaho, was received with cheers and applause, at Boise, Wednesday. The streets and hotels were blocked by the cheering throng, fire engines blew their whistles, street cars rang their bells; hundreds of friends surrounded him, and the band played "Hail to the Chief," all of which proves conclusively that the people know that the Senator has been the victim of conspiring political enemies. The verdict will be received with much satisfaction throughout the whole country.

The rascal Radding and his associates who tried to blacken the good name of Mayor Lane of Portland, by a most contemptible plot, have been completely exposed and should be sent to the penitentiary for the rest of their natural lives. Anyone so mean, debased and low, is dangerous to any community, and not fit to be at large, and the sooner they are put behind the bars the better for the commonwealth.

The Eugene Register has another guess coming. It says:

"The governor has a son who is a doctor and another who is a lawyer. He could educate neither of them at Eugene at the state university."

The governor has but one son, Dr. Charles Chamberlain, of Portland.

F. F. Seavers, who owns a five-acre tract in Benton county across the river from Albany, has 1,000 White Rock chickens which he has raised since starting into the chicken business less than a year ago. He raises poultry on a scientific basis and says he has little trouble in keeping his poultry in good health.

Commenting on Benton county, the smallest county in the state, winning the first county prize at the state fair, the Corvallis Republican says: Benton county has always had a reputation for richness, and year by year this reputation is growing. As new settlers come in, and the large farms are reduced in size and more thoroughly cultivated this county will be able always to maintain her name for progressiveness and the richness of her resources.

SHOULD HAVE A HEARING

The following resolutions were passed by the Oregon & Washington Lumber Manufacturers' Association, endorsing the proposed amendment to the Interstate Commerce Law providing for a hearing before any changes in interstate freight rate may become effective:

"Whereas the Interstate Commerce law now in effect, does not contain any provision whereby a hearing is required before a change in any interstate freight rate may become effective, and

"Whereas, experience has fully demonstrated the urgent necessity for an amendment to remedy this serious defect; therefore, be it

"Resolved, By the Oregon & Washington Lumber Manufacturers' Association, representing an annual output of one and one-quarter billion feet of lumber with a value of nearly twenty millions of dollars that at the coming session of Congress an amendment shall be offered and strenuously urged, providing substantially that when any railroad company seeks to advance or lower any interstate freight rate, or change the classification of any commodity, it must if objection be made thereto, receive the approval of the Interstate Commerce Commission before such rates or changes in the classification shall become effective. Be it further

"Resolved, That a copy of these resolutions be sent to every Senator and Representative in Congress and that every mill owner, manufacturer and shipper in the United States be asked to co-operate wherever possible in the passage of this amendment of the Interstate Commerce law."

Equipping the Mill.

Frank L. Bean, of the Fitzhenry-Bean Lumber company, went to Portland last evening to look after the machinery ordered for the new mill at Coburg. They expect to have the machinery on the ground within a week and in all probability will be ready for business by the 20th of the month. The principle object of Mr. Bean's visit to Portland is to buy additional machinery as the mill orders already admit of a mill of greater capacity than the company had at first intended to build.—Register.

Proof Positive.

Portland, Oct. 2.—Complete and incontrovertible proof of the existence of a diabolical plot on the part of political enemies of Mayor Lane to blacken his good name, and if possible drive him from his position as the executive of Portland, was furnished this morning by the statement of A. N. Wills, president of the city council, that E. E. Radding some six weeks ago had proposed to him and Thomas C. Devlin, a plan by which Mayor Lane could be trapped in his office by a woman. The plan was proposed by Radding and was turned down by both Wills and Devlin, according to the statement of Mr. Wills, and was evidently taken to other and more complaisant men.

Councilman Wills is a political enemy of Mayor Lane and has in the past been opposed to him on many political problems affecting the government and conduct of the city and its affairs. To him, and to Thomas Devlin, defeated by Lane for election to the Mayor's chair, Radding took his dastardly plan after weeks of ingratiating effort to make himself friendly and acceptable to the men, and he trusted to this political enmity to secure their acceptance and approval. Mr. Devlin confirms the statement made by Mr. Wills.

University Notes.

University of Oregon, Eugene, October 1, 1905.—Although the girls' dormitory and the new library building have been completed it is not probable that they can be used this year, on account of lack of money for furnishing and heating them. The ret-erendum has tied up the funds with which it was expected to install an additional boiler at the heating plant. The two boilers in use now are already taxed to their fullest capacity. The University is badly crowded for additional recitation rooms and a dormitory for girls was especially needed. The main library room in the new building has been partially fitted up and will be used.

With a view to bringing the work of the University within the reach of the teachers of the state and others who find it impossible to attend the regular sessions, the department of Education of the University is announcing a number of correspondence courses. No charge is being made for tuition, and the

only expense attached will be that of postage and books. The State Library Commission is co-operating in the matter of furnishing libraries. Courses are now being given in English Classics, (State High School Course,) Shakespeare, History of England, Pedagogy and Algebra.

were sold only from certain points to other certain points on certain trains and days of the week: This rate is over all the lines in America, good on all ordinary trains, and on sale every day while it lasts.

"Of the various towns and cities Corvallis got the best results, 6000 answers all told. Astoria is spending the most money, not even excepting Portland. Portland is receiving about 250 replies a day right now, all new ones, too. The country papers all over the state deserve the greatest credit, perhaps, outside the commercial bodies themselves, for many of them keep the table of rates running at the head of their editorial columns, or on the front page of every issue and that costs money."

At the Chamber of Commerce it was learned that hundreds of new colonists are arriving in Portland daily. How many are reaching the other points in the state direct cannot now be calculated with any sense of surety, but the indications are that the months of September and October will far exceed the months of March and April in the settlers attracted to Oregon.

The railroads coming into Portland report that more people are arriving daily in this city than during the Exposition. The baggage rooms are jammed full, and surplus baggage has to be piled up outside under the shed till there is room for it inside. Four box cars of baggage stand in the station yet unloaded. The people arriving are, by the tickets collected by the O R & N for the week ending September 8, as follows: Reached Huntington this year, 1450; last year, 687. Of these 1450 newcomers 245 went to Portland; 345 to Puget Sound points; 125 to Spokane; 457 to points north of Portland; and the rest were distributed to Baker City, Walla Walla, Pendleton, Hood River, The Dalles and other points in the state.
