## Meeting of Democratic Central Committee.

## TIMBER MAN ARRESTED

David Parmenter, the Gay Old Bigamist Captured in Omaha. Divorces Granted.

Alfred Johnson of Cottage Grove has located a mining claim in the Bohemia district which he has called "The Relapse."

A log drive of nearly 8,000,000 feet is being brought down from Fall creek to the Springfield mill for the Booth-Kelly Co.

Last Saturday divorces were granted by Judge Harris to Mrs. Lucetta Thomas of Cottage Grove; Andrew Markette of Crewell and Zora Thorndike of Eugene.

The Booth-Kelly Lumber Co. have about 4,000,000 feet of logs boomed at the mouth of the Mohawk and will turn them loose this week and run them to the Coburg mill where they will be left in the pond until needed.

The Booth-Kelly company has a crew of log drivers bringing lost logs down the river from the head of the race at Springfield to the Eugene Lumber Co's boom. They have gotten as far as the Springfield bridge and will soon have 1000 or more logs in the boom here at Eugene. After they have finished that work they will gather up all logs belonging to the company between Eugene and Corvallis and drive them to the latter place where they have been sold.

David Parmenter, who was indicted by the last grand jury on charge of bigamy and who was bound over to court in the sum of \$400, the bond being furnished by a number of old soldiers of the city, was located and arrested at Omaha a day or two since. Deputy Sheriff C. C. Hammond left Monday morning on the Cottage Grove local for that place and will bring the old man back with him to stand trial for his foolish acting. He will not be hard to bring as he is an old man and anything but active.—Register.

The Democratic Central committee met in Eugene last Saturday. The committee discussed plans for the coming campaign and decided to accept Statement No. 1 as the paramount issue on the legislative ticket. A motion was made and carried that the officers of the central committee be empowered to select delegates from the county to the state convention at Portland, to be held some time next month, and that the delegation be instructed to use all honorable means to have the state convention instruct the Oregon delegates to the democratic national convention to vote for William Jennings Bryan as the nominee for president.

M. T. Devereaux, a young timber land locator who resides in Eugene was arrested Saturday by Sheriff Fisk and Deputy Sheriff Hammond upon a warrant from Spokane, Wash., charging him with obtaining money under false pretenses. Deputy Sheriff Pugh of Spokane arrived here with the warrant and he left on the noon train Saturday with his prisoner, bound for Spokane. Devereaux having waived extradition. Devereaux is charged with locating a number of people on worthless land after having shown them good timber land in the vicinity of Spokane, a woman residing there having made the complaint against him. He resided there before coming to Eugene about a year ago, and the offense is alleged to have been committed before he came here. He feels confident that he will be cleared of the charge. His wife and two children reside in Eugene.

# SALOONS OR NO SALOONS?

In brief we have here stated the living issue before the American people. Our nation, like a sleeping giant, is awakening to the importance of the issue. The present vigorous campaigning against the saloon is, in the language of the New York World, "Without a parallel since abolition times." The recent landslide in Illinois, Nebraska, Colorado and Michigan is making the saloon element gasp for breath. At last they recognize the fact that it is only a matter of time until their business is doomed. The outcome is inevitable. Social progress demands it. God wills it.

The ridiculous scramble of the National Liquor Dealers Association to "clean up" in order to save their business from annihilation is laughable in the extreme. As well talk about "cleaning up" a pig sty! They have sinned away their day of grace. "Their coarse efforts in trying to 'run things' are being answered in tones of thunder, 'get out!'"

"The 'personal liberty' howl needs attention. Are we to understand from the saloon keeper's appeal that he places his business on a par with that of the merchant? There is a very decided distinction to be made. In promoting his business the saloon keeper runs counter with my personal liberty and that of my neighbors. No man is a law unto himself. I have the right, in the exercise of my personal ability, for instance, to swing my arm as much as I please. But when my arm comes in violent contact with the person of some one else then my personal liberty must be instantly interfered with. As long as the boasted 'personal liberty' of the saloon damages the 'public health and the public morals' so long must the business be placed under the ban of law. Who, in the light of well known facts, dares deny that this 'colossal crime of human history'—the saloon business—is the most deadly foe of the public health and morals? The 'personal liberty' of the saloon keeper is the 'personal liberty' of a mad man running amuck.

Let us apply to the liquor business the decision of the United States Supreme court, from which we have quoted, "No legislature can bargain away the public health, or the public morals. The people themselves cannot do it, much less their servants." (Stone vs Miss., 101 U. S. Rep 814-819.) Does intoxicating liquor effect the public health or morals? Let the same high court answer. "We cannot shut out of view the fact within the knowledge of all that the public health, the public morals, and the public safety may be endangered by the general use of intoxicating drinks." (State of Kansas vs Ziebold and Habelin, 123, U. S. Rep. 623-662.) Examine the records of insane asylums and penitentiaries and there, too, find an answer.

Go to, now, you well wishers of the great American commonwealth! Why all this hue and cry against our worthy citizens whose business measure up so bravely to a high standard? "Brutus is an honorable man." Why place barriers

in the way of him who deals out health-giving chemical and vegetable rottenness beside which the putrid puss of a festering sore is clean? Why point the finger of scorn at that honorable man who defies law and order, and who educates outlaws and anarchists? Why hail as the moral dregs of a civilized society him who, with a high, black hand, pours out liquid hell? "Brutus is an honorable man." Why protest against a peaceful, honorable business which in 1890 was the direct cause of murder in these United States? Why? Shame on you for "lambasting" the business of such an honorable man!

We need the saloon keeper's help to pave our streets—with skulls, cemented with the blood and tears of widows and orphans. Out upon this cry, "Its time for a reformation." Sew up your lips with a pack thread and cease railing at our most enterprising wealth and health producing, brain boggling, gin-besotten honorable man! We can't, we absolutely can't get along without this splendid type of American manhood. Why, without him and his heavenly business, who would make the merry mill go round that receives boys into the hopper and annualy grinds out about two hundred and fifty thousand drunkards and drunkards graves! I rise in defense of this worthy, than whom there has not risen a greater since the day Cain slew his brother.

Stand back, give way you social and economic reformers! Behold the conquering hero comes, clad with morning light! With hat a tilt and a sneer on his face he delivers his solution to some of the problems that vex our patient souls.

"Down, you slaves! You dolls! Down at my feet with your annual tribute of one billion two hundred and fifty millions of dollars! And in return I grant you the ceaseless blessings of poverty and woe. I shall continue to wreck your homes, beat down the brow of your manhood and blacken the virtue of your womanhood. I shall continue to send your bloated bodies to the grave and your ruined souls to hell. Question not my authority!" (Here he flaunts his license.) "You call me king. It is well. But his!—an open secret—the power behind my throne is the man who holds the votes."

And now, directly, a few words to "the party of the first part." Don't squirm, stand still and take your medicine, for you, Mr. Voter, are the man I'm after. The degenerate who dishes out the "red riot" is a pitiable victim of circumstances over which he has no control. He cannot help being a saloon keeper any more than a swine can help being a hog. Of course, you, and I, friend, have nothing personal against the helpless "victim of circumstances," but we are getting a trifle anxious to chloroform his business. There's no deep-seated malice abroad against the bed bug, but most of us have a "mighty hankerin'" to bankrupt his business.

## RATTLESNAKE DEN IN LORANE COUNTY

J. W. and T. M. Doak, who were in town from the Lorane country Monday tell a pretty large rattlesnake story, but its truth is vouched for by well-known residents of the vicinity. They say that 47 rattlers, mostly good sized ones, have been killed in a den discovered on the Jerry Pipes place recently. The killing occurred on several different days when the weather was warm and bright and the snakes came out of their den to take a sun bath. On Sunday last, fourteen were killed, says the Guard.

Up to the time this den was located and watched no one in the vicinity had any idea that there were any rattlesnakes to speak of in the neighborhood and the large number killed to date has occasioned much surprise. The skins, rattles and oil of the snakes are taken care of and preserved for various uses.
