Died.

GRAY—At the family home in this city, Wednesday morning May 13, 1908, Caleb Gray, aged 88 years, 8 months and 4 days, of Bright's disease.

Deceased was a native of Clark county, Indiana and crossed the plains to Oregon in 1852 after burying one child in what is now Nebraska and when the summit of the Blue mountains was reached a daughter was born to Mr. and Mrs. Gray. In August 1852 Mr. Gray located a donation claim in Linn county near Halsey, which he developed into a nice farm and owned up till the time of his death. Two sons died on this farm and Mrs. Gray died here in 1875 and he married Mrs. Frances E. Detwiler in 1877 and three children were born to them, one of whom is still living, Mrs. H. K. Metcalf of this city. Two of Mr. Gray's children survive him, Mrs. Alice Cozier of Bellingham, Wash., and Howard Gray of Montana. C. G. Gray, a son of Mrs. Gray, completes the list of surviving children.

For 17 years, or up till within four years ago, Mr. Gray was engaged in the drug business at Halsey, when he retired and came to this city a year and a half ago to reside, having purchased a little home on Wall street. Mr. Gray was a grand old pioneer gentleman, had been active in Oregon affairs and was held in the highest esteem by all who knew him. Funeral services were conducted Thursday at Lone Pine cemetery near Halsey and was largely attended by old neighbors and friends.
