Place Receipts **Out West**

Washington, Nov. 28 .- The names of six government depositories which are to handle the receipts of the United States Forest Service, after December 1, when organization for the administration of the National Forests will be removed from Washington to six just been announced.

The designation of western ceived from timber sales, permits

for stock grazing and for special uses of various resources in the National Forests is an innovation

which will mean that all the receipts of the Forest Service in the future will be deposited to the credit of the treasurer of the United States and made available for circulation in the part of the country from which it is derived, within the limits of the amounts allowed by law for government deposits, instead of being forwarded to the treasurer at Washington. The banks which have been named and which have all consented to serve the government are located in the district headquarters of the Forest Service at Denver, Ogden, Albuquerque, Missoula, Portland and San Francisco. They are as follows:




