CAN MR. HARTOG BEAT THIS?

The writer in making the usual rounds of the town Thursday could but note on this springlike day the many evidences of our even, mild and delightful climate as compared with that of the east and middle west just now. In many dooryards were to be seen roses, pansies, daisies, sweet williams, and chrysanthemums in full bloom in the open air. At several places we noticed nice beds of fresh green lettuce, onions and radishes growing in the gardens, while a few of our citizens were found planting early garden and flower bulbs. But the incident to most impress us and which makes all of the fantastic ploy, exultation and felicitating of our esteemed contemporary, "Nobody's Magazine," when exploiting Oregon weather and superb climatic conditions, sink into utter insignificance, was a sight viewed from the river bridge on Main street, the amusing spectacle of a number of happy school lads barefooted, wading and splashing in the placid waters of the Upper Willamette river, and this on the third day of December! Here we could but picture in our mind the extremes of an Oregon and eastern winter—here the school boys barefooted, wading and splashing in the limpid streams; there the school boys, fur-clad, skating and sleighing on the streams and ponds. Think this over, ye snow bound, blizzard beaten, frost bitten inhabitant of the far east and middle west, and then resolve to come to Oregon.

BUSINESS AND LOCAL OPTION

It is a notable fact that many great papers all over the country are lining up against the liquor business. Here is the Spokane Review, one of the leading papers of the west voicing an opinion on the relation of business and local option in the following:

"The stock argument advanced by defenders and beneficiaries of the liquor traffic against local option is that the suppression of the liquor traffic injures business. This argument is a delusion and a snare.

It was at one time accepted by a great many business men who accept it no longer and it has almost entirely lost its force with citizens generally.

"About the only kind of business injured by the suppression of the liquor traffic is the liquor business. The money which would otherwise be squandered for intoxicating liquors is quickly turned into other channels of trade, which profit accordingly.

"Mayor H. B. Carpenter of Pullman declares that one of the most notable features of that town since the saloons were abolished has been the improvement in business. The abolition of the saloon has been a strong factor in this increase and is so recognized by business men."

The Oregonian, while antagonistic to the temperance movement in this state—at least from a monetary standpoint, once in a while gives away its true moral sentiment on the question, at least when it comes close home to it as it did last week when a prominent attorney while in a drunken frenzy shot to death a brother attorney, thus placing another blot on the fair record of Portland, regarding which the Oregonian says editorially: "Of course, there will be the defense of irresponsibility—probably through alcoholism. But alcoholism is no excuse. It is itself an offense. It is high time juries should teach that men can't use liquor for stimulation to murder, and escape the penalty. Offensive a spectacle as the gallow is this community needs it still, and so does many another."

It's comical to note the number of business men who "don't believe in advertising, but you will always find their card associated with some freak scheme of advertising," which is always placed where the smallest percentage of the public would see it.

This city cannot afford to give up the Cottage Grove local, it being rumored that it will stop at Eugene, and be known as the Eugene-Portland local. Here and now is where and when the Cottage Grove Commercial Club should get busy.

It has been predicted that the great Y. M. C. A. movement which resulted in raising \$51,250 at Eugene in seven days, is to be felt in many of the other cities and towns of Oregon.

PROMINENT CORNER LOT ON MAIN STREET CHANGES HANDS

Dunbar & O'Loone Purchase Martin Property---Will Build a New Two-Story Brick in Spring

An important real estate transaction was consummated in this city this week in which Messrs Dunbar & O'Loone, successors of the Garman, Hemenway Co., become the owners of the prominent corner lot on Main and Fifth street known as the Martin property on which stands the single story frame building occupied by Lincoln's meat market. By the purchasers of this valuable property the Leader is informed that they expect to take possession of the premises soon after the first of the year, temporarily repair the old building, move it to one side and occupy it while a fine, modern two story brick is being built for them. Messrs Dunbar & O'Loone expect to move into their temporary quarters by February 1st and let a contract for their new brick just as soon as weather conditions are favorable for building in the spring. Messrs Dunbar & O'Loone have built up a good business in this city and since they completed their fire sale have put in a large stock of new and up to date goods, in the Phillips building.

Mr. O'Loone remarked this morning, "we like Cottage Grove and the people here and have decided to engage in business permanently in this city. As evidence that we are here to stay and mean business we have invested our money in business property, which we will proceed to improve and occupy."
