POOR TRAIN SERVICE ALL ALONG THE LINE

The Jefferson, Marion county Review says:

A change of train time went in effect Tuesday. Passenger trains now leave Jefferson as follows: Northbound—6:28 a. m.; 2:35 p. m. Southbound, 11:25 a. m.; 7:24 p. m. The Cottage Grove local carries no more mail, so we do not receive our evening mail from the north until 8:30 p. m. With but one mail per day from the south, though we have four northbound passenger trains, the authorities have finally worked the mail schedule into the most miserable condition possible, as well as the most inconvenient, so we suppose they are satisfied. There is no apparent reason why the Cottage Grove local should not carry mail both from the north and south, except that it might accommodate the people too much.

The morning northbound train comes too early and the one in the afternoon too late, so travel has been light this week.

Mrs. Gould Granted a Divorce.

Mrs. Howard Gould was granted a divorce and \$36,000 a year alimony. She asked for \$250,000 a year.
