EXCELLENT MAP AND WRITE UP.

The Southern Pacific has issued a most excellent map of Oregon, copies of which have been received by the Leader.

It is rated as the most comprehensive and complete map ever published in large quantities, and the review of the state's resources on the reverse side has been compiled with the utmost care.

The publication made its first appearance at the great Land and Irrigation Exposition recently held in Chicago, and the demand for it was amazing. We speak of this fact not merely to laud the folder, but to emphasize the almost insatiable hunger everywhere for trustworthy information about Oregon, and the increasing need for united effort on the part of Oregonians to satisfy that hunger.

The railroad companies responsible for this publication have inaugurated a campaign of world wide scope to place it in the hands of every person who is anxious to know about Oregon, and we feel confident that Oregon Commercial clubs and newspapers can be relied upon for effective support in this worthy cause—the exploitation of Oregon's resources and advantages.

The success of the twenty-year electric light franchise in the municipal election last week was a fine compliment to Messrs Kem and Shinn, owners of the plant. The days of big herds of sheep in Crook and many other Eastern Oregon counties are nearly over. The assessment shows 88,000 less sheep in Crook county this year than last year. The range is being settled up by farmers who will raise wheat, hogs and fruit, for which that district is well adapted. The days of the sheep herder and cow boy in Oregon are about over.

The troubles between the railroads and the 75,000 conductors and train-men have been adjusted, the employes to receive a ten per cent advance in wages. That means an extra five million dollars to trainmen for 1911.

SHIPPING RICH ORE FROM BOHEMIA MINES

About one hundred more sacks of rich ore from the West Coast mines in the Bohemia mining district was received in Cottage Grove Saturday and was sent on its way to the smelter. This ore runs several hundred dollars to the ton and was the second shipment made from the West Coast mines last week. At this rate the new management of the West Coast will soon wake things up in Bohemia and cause the outside mining world to set up and take notice.

Wrestling Bout a Draw

The much talked of wrestling match between the German-American middle weight Champion Carl Busch and Emmett Hall, a husky young local athlete and wrestler of Oakland, Oregon, was pulled off at the armory Saturday evening in the presence of a good sized crowd, one-fourth of which was women. A lively eight round preliminary boxing contest between two youths of this community opened the evening's exhibition. The wrestlers were then introduced, Busch weighing 160 pounds and Hall 155 pounds. Early in the game Busch gave evidence of being the most powerful man, but Hall was more active and speedy. After about 15 minutes of maneuvering for an advantage, Hall by some cat like stunt had Busch seated on the mat with his picture toward the wall, but Busch soon succeeded in gaining his feet. After this Hall worked principally on the defensive and during the two hours struggle Busch only succeeded at two different times in putting Hall on his hands and knees but at no time did he succeed in putting Hall on his back, and each time Hall succeeded in regaining his feet. The Leader was told by an Oakland friend that Hall did not know he had signed up with a professional until after the papers were returned to Cottage Grove, but believed he was to have a bout with some local man here. He is said to have only had three days training for contest, under which conditions he certainly made a good showing. When the gong sounded at the end of the two hours struggle both of the men gave evidence that they had been working for their money and the bout was declared a draw. Busch stepped to the front of the stage and stated that Hall was a very clever young man but expressed the opinion that he could throw him in less than two hours on a larger mat. All above 35 per cent of the gate receipts went to the wrestlers amounting to about \$50 each, the balance going to the military club. A large crowd of Oakland citizens came down to witness the match. Hawley, the O. A. C athlete and wrestler, acted as referee.

Schmitt, and the bride's sister, Miss Genevieve Roberts, of Myrtle Point, being present. Mr. and Mrs. Schmitt left at noon following the wedding for a two weeks' visit with relatives at Portland, Seattle, Hillsboro and Cornelius, after which they will be at home in the new residence erected by the groom in Creswell.

Tax Levy Fifteen Mills.

Ten mills for the general fund, three for park, and two for sewers, is the tax levy for 1911 as made by the council at an adjourned session Thursday night. This is five mills less than last year's levy, and less than desired by Mayor Kime, Aldermen Lawson and Hogue, and more than it would have been had Alderman Wheeler been in full authority. The county levy will probably be 12 mills, the school levy is 5 mills, making a total of 32 mills, or on the whole 11 mills less than one year ago. Councilman Wheeler stated the \$30,000 bond issue would take up all outstanding warrants and leave money in the treasury, and with a clean score additional warrants might be issued. He believed a high levy detrimental to the progress of the city. In this contention he was supported by Alderman Wallace.

Councilman Lawson, who made an investigation of the books, said the running expenses of the city for the past year, including the purchase of the rock crusher and steam roller and the installation of the former, amounted to \$15,850 out of the general fund, but operating is not included. The abatement for bridge \$550, and the sewer east of the track, \$1600, also came from this fund. Subtracting these from the \$15,850, would leave \$8,133 that it cost to run the city.
