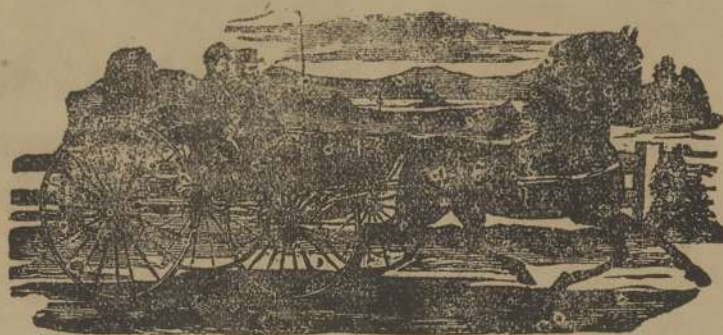
River Street Assessment Notice.

TYPHOID EPIDEMIC IN EUGENE NOW

Boil the water!
This is the imperative injunction of State Health Officer Calvin S. White, to Eugene in his official capacity to investigate existing conditions.

In company with Dr. F. W. Prentice, county health officer, Dr. White visited the homes of the afflicted and found conditions which warranted the posting of notices warning residents of the city of the present insanitary condition of the city water supply.

"The public health must be safeguarded against the prevalence of contamination in Eugene's water supply," stated Dr. White to a Register reporter.

"To longer with-hold the facts would be little short of criminal. There are at present between 40 and 50 cases of typhoid in Eugene and five deaths have resulted within the past ten days from this malady.

Analysis of the city water supply, made by Professor Pernot, bacteriologist for the state board of health, and completed last Tuesday, disclosed the presence of human sewage or colon bacillus in large quantities. Two samples taken from the river, one at the intake and one from a faucet in a down-town office, showed that the present system of filtration removed about one-half of these organisms. There is no filter in the world that will remove colon bacillus from water without the use of chemicals.

"Of these typhoid cases, prevalent in the city, the households of 24 use the city water exclusively, eight use well water and two could have come from outside points. At one house occupied by a family who recently came from Illinois, two cases of typhoid have developed in young girls. In this case the pump is located over a well on the back porch, and the cesspool is six feet away drained down two feet from the well. The whole mass has overflowed the ground, and all manner of filth has been deposited in this hole. We dragged out a pile of old sacks, saturated with slops and human sewage, making a nuisance which should not be tolerated in the most barbarous country on earth.

"The only safety for Eugene is to boil every bit of water used for domestic purposes. This must be done until such time as the new filter system is completed, the reservoir—which is in a filthy condition—emptied and scrubbed out and all dead ends of pipes, used in the present water system, opened and flushed.

"Of those cases directly due to wells, the majority are in Fairmont addition, where shallow wells, flat land and numerous cesspools will always be a menace to public health.—Register.
