BOY DENIES

HIS OWN MOTHER

Eugene Or., Nov. 9.—"Some day, the real Barnard Marvin will hear of this fuss that is being stirred up here about dual personalities and lost memories and come back to this town, and there will be an awful row," was the statement made today by a man who in the face of his almost heart-broken mother maintains that he is George A. Lewis, a working man, and not Barnard Marvin, the son of Mrs. Leiberge, and a Berkeley graduate.

"He will be one of the maddest men in the United States," he continued. "I am mighty glad that I have kept clear in the matter, all the way through. He can't have anything on me when he does come back."

His case is a complete puzzle to all who have spoken to him. It is beyond belief that a mother could be mistaken in her own child, when she had seen him less than two months ago. Mrs. Leiberge is a practicing physician, and a woman of brilliant education and wide knowledge of the world. She does not even attempt to verify her knowledge, because she is positive.

On the other hand, Marvin, who insists that his name is Lewis, is equally positive that he is a strange victim of a case of mistaken identity. He talks rationally and clearly, and when listened to it is almost impossible not to believe him, for he is so unmistakably sincere. His haziness as to his past previous to two months ago is the only irrational mark about him.

"If there is a man in the world whom I would like to meet more than any other," said he today. "It is this Barnard Marvin. Imagine yourself being taken for her son by a woman you never saw before. I read a story not long ago where a woman mistook a man for her husband, and was positive for a time that she couldn't be mistaken, but I never supposed that I would find myself in about the same position. It is unheard of. Sometimes get wondering myself if it could be true, but I know who I am."

Notwithstanding that he maintains he is a plain logger, he talks entertainingly, and at considerable length of the classic writers. He knows Virgil well, and is familiar with the philosophy of Plato and Aristotle. He is a close student of Homer, and the wanderings of Ulysses through strange land amid stranger adventures hold a peculiar fascination for him, he says.

Dr. W. Kuykendall, who has made a careful examination of young Marvin, says that there is no doubt whatever that it is a strange case of dual personality. There is not the remotest possibility, says Dr. Kuykendall, that Mrs. Leiberge could be mistaken, and in addition, young Marvin's mind is a blank beyond six months ago.

"The cause might have been a blow on the skull and it might have been overwork and eye strain said the doctor. "He is likely to change back to his former self at any time without specific cause."

REV. DR. NAVE PASSES AWAY

Rev. Dr. Nave, a former minister of the Presbyterian church in this city, passed away suddenly, concerning whom the Oregonian says:

As the congregation, gathered to hear Gipsy Smith, the evangelist, was singing the first hymn at the services yesterday afternoon, Rev. Henry L. Nave, pastor of the Montavilla Presbyterian Church, quietly passed away, following an attack of heart failure five minutes before.

Few persons in the audience knew until after the services that death had occurred in their midst.

Rev. Mr. Nave was sitting in the middle of the section reserved for ministers only, talking to Rev. W. H. Hampton, who sat beside him. His voice suddenly broke, and Rev. Mr. Hampton noticed that he had turned pale. Rev. J. W. McDougall, who sat just behind, called Dr. S. M. Mann, of Linton, Or., and the three carried the dying man to the rear of the building.

The seizure took place at 2:25 o'clock and at 2:30 Dr. Mann said that he was dead. During part of the service the body lay on a bench behind the building, and was removed while the evangelist was speaking, to Dr. Nave's undertaker's parlors.

Rev. Mr. Nave with his son, H. D. Nave, roomed at the home of Mrs. Ailsworth, 156 East Eightieth street, in Montavilla. For some time he has suffered from heart weakness but yesterday appeared to be in excellent health. He preached with his usual vigor at his church in the morning.

Rev. Mr. Nave had been in Portland three years, but had occupied pulpits in the Willamette Valley for the last 10 years. Two sons are attorneys in New York, and the other is an instructor at the Portland Y. M. C. A.
