O. P. & E. TO BE EXTENDED

Money Secured to be Used in Improvements.

The Oregon Pacific & Eastern Railway, under which come the old Oregon & South-eastern is now doing business, a reorganization having taken place the first of January, has filed a mortgage or trust deed to secure a loan of \$500,000. The deed is given to the United Trust company, of San Francisco, and the instrument is dated Jan. 1, 1914.

The Oregon & South-eastern operated the Cottage Grove-Bonham railroad for a number of years. A reorganization of the stockholders took place recently and the new name is a result. The \$500,000 secured on this mortgage will be used in betterments and extensions.—Guard.

LINE FROM EUGENE TO COOS BAY PROGRESSES

Claude Nasbury, a Marshfield business man, reports that fine headway is being made in the construction of the Willamette Pacific line from Eugene to Coos Bay.

By next March the line will be completed and under operation from Eugene to Florence, or to tide-water on the Siskiyou river and from there to Marshfield it will be but about a five or six-hour stage ride down the beach.

This will prove a great boon to the people of that section. Then, of course, we shall have to wait until the heavy tunnel construction and other engineering features are completed southward from Florence. The biggest job is on the 4200-foot tunnel, on which work will be prosecuted throughout the winter. The tunnel has been driven about 1500 feet already, and when it is completed, 18 months from now, the road will be ready for operation and we shall have quick and direct communication with Portland by rail. A gasoline motor now gives regular service between Marshfield and North Bend.—Telegram.

POLITICAL POT WILL BOIL DURING 1914

The Oregon campaign booms for 1914 are due. The primaries will be held on May 15, so the campaign will be a long one.

Politics will play an important part in 1914. It is to be a busy year politically and it will spread along for the entire 12 months, so that those who take interest in such matters will have an abundance of gossip and campaigning to occupy their attention.

First off, there will be the launching of booms and then will be re-registration for everyone. Then there will be the primaries; later the election and lastly frame-ups for the Legislature. This year there will be a state ticket elected and a county ticket. A legislative ticket is also to be selected by the voters.

Main interest will center around the contests for United States Senator and for Governor. Senator George E. Chamberlain's successor is to be elected and he desires to succeed himself. R. A. Booth has already announced himself as an aspirant for the Republican nomination. This will be the first direct election of United States Senators under the amendment to the Constitution of the United States. For the past eight years Oregon has had practically the direct election of Senators by means of Statement No. 1, which has served its purpose, and hereafter candidates for everything from Constable to Circuit Judge need not expect to gather votes by declaring themselves for Statement No. 1. Warm as the Senatorial fight will be, it will be mild compared to the primary fight for the nomination for Governor on the Republican and Democratic tickets, as there is a flock of aspirants already in the field and more coming.

An active contest is expected for Supreme Judges, as three are to be elected.

Six months will elapse between the primaries and the general election, which is exceptionally long. It is this excessively long campaign that worries candidates. After the primaries, however, those who secure the nominations will remain under cover for four or five months and will not make their final campaign until the last month.

When the general election has been cleared away, politics will continue active, for it will then be time to prepare for the Legislature and less than two months will elapse between the November general election and the convening of the Legislature.

COTTAGE GROVE MILITIAMEN SUMMONED TO COPPERFIELD

Capt. Johnson Mobilizes and Equippes His Men on Record Time and They Absorb State Wide Interest

Last Thursday morning Capt. J. C. Johnson received a telephone message from Governor West, requesting that four members of Sixth Co. C. A. R. be commanded to report, fully equipped, before Col. B. K. Lawson at Salem on the afternoon of that day. The order was received by Capt. Johnson at 9:30 o'clock a. m., and he found that Butte Mooney, one of the militiamen wanted, was at his home nine miles in the country, while the other three men were scattered about this community. He telephoned Mooney to start for town at once, stating that he would be met by an automobile, and by 11:10 a. m. Captain Johnson had his men fully equipped, and starting by auto for Eugene where they arrived at 12:45, they took the valley electric for Salem, reporting at the time and place requested by the governor. Headed by Col. Lawson, the local militiamen left Salem Thursday night for Baker county, to enforce, if necessary, the Governor's orders to close the saloons at Copperfield, a Baker county town.

The members of Sixth Co. summoned by the Governor were: Quartermaster Sergt. Wilson and privates Mooney, McDole and Lee Tennis. Capt. H. K. Metcalf joined the squad at Salem. Capt. Johnson states that six hours would be ample time to mobilize and equip Sixth Co. for service.

Lawson Defies Officials.

Copperfield, Jan. 3.—When served with an injunction today issued by Judge Anderson of the circuit court at Baker, and which had been sent here by wire, Colonel B. K. Lawson, in charge of the governor's crusading forces, tore it up and threw it into the officer's face. The injunction sought to restrain the colonel from keeping the saloons of Copperfield closed and from preventing the mayor and councilmen from fulfilling their respective functions.

Newspaper Photographer Dies

W. F. Shanafelt, for a number of years staff photographer of the Telegram and Oregonian, and later operating a private studio, died at the home of his sister, Mrs. W. J. Bennington, Lawrence, Kan., New Year's eve. He had been visiting relatives in Kansas and Oklahoma for several months past, but has been in poor health for the last three years owing to a stroke of paralysis. Mr. Shanafelt was 55 years old, and is survived by his widow and three children.—Oregonian.

Colonel Lawson telegraphed the governor asking for immediate reinforcements of militia. "I don't want Sheriff Rand to come up here and put me in jail," said Lawson, "and I am going to have a force sufficient to insure against his doing it."

All the saloonkeepers under arrest today refused to ship their liquor and fixtures out of town upon Lawson's order and their stocks were confiscated. Colonel Lawson appointed a provisional mayor and council, but announced that martial law would continue. A strict censorship on telegraph and telephone messages was exercised and not until tonight at midnight would Lawson allow the newspaper men to file their dispatches.

Escape is Attempted.

Copperfield, Or., Jan. 4.—Attempting to flee from this place Councilmen Wiegand and Warner, who were deposed and placed under arrest last week by Colonel B. K. Lawson when he put Copperfield under martial law in order to close the saloons, were captured by members of the Oregon National Guard today just as the unseated officials started to speed out of town on a gasoline railroad speeder.

Both men had been pleading since their arrest, Thursday, to get to Baker, but their appeals fell on an adamant heart. They pleaded illness on the part of relatives in Baker, offered to give bond, did everything, but Colonel Lawson acted as though he heard not at all and his only reply was "you stay in Copperfield."

Move on Huntington.

Salem, Ore., Jan. 5.—Governor West, being notified by Colonel Lawson tonight that he was moving his men to Huntington, and that he would send a part of them home if ordered to do so, telegraphed the Colonel as follows:

"Send all unneeded men home, but do not under any circumstances submit to arrest or interference by local authorities. Will support you with entire National Guard if necessary."

An Unusual Gale.

The Hoe Lumber Co., Messrs. Gawley, Rissue & Crowell, sustained quite a loss from the little coast gale which swept over from the old Pacific last Thursday night and which laid low several hundred feet of their newly constructed flume from their mill to the railroad track on the east end of the Felix Currin farm. About four days work for a small force of men and a few hundred feet of additional lumber will repair the damage. A few trees were uprooted in the same locality, and old sheds unroofed and fences racked in the Row river valley above and about this mill.

WATER BREAK IS BEING UNDERMINED

The waterbreak, constructed of pilings, logs and stones, erected in Row River last summer a short distance below the steel bridge at the Spray place to protect the county road at that point from winter washouts, was undermined by the swift current of Row River during the recent little raise in the river and is on the verge of collapse, the west end of the dike having already broken off. Some state that the dike should have been built at a greater angle down stream which would have resulted in less resistance from the current and would have just as effectually directed the current away from the crumbling east bank of the river. However, this is a matter upon which wise men disagree.
