GOVERNOR WEST FIRES WHITE

Salem, Or., Jan. 6.—Declaring that he had discovered that Samuel White, judge advocate-general of his military staff had been extending advice to those in sympathy with the very violators he is attempting to reach in Copperfield, Governor West announced today that he had removed him.

White is one of the leading democrats of the state.

The governor's explanation follows:

"Samuel White is judge advocate-general and member of the staff of the governor. His duty is to advise the governor and officers of the militia in regard to their duties. We find that Judge White's advice is being extended to those sympathizing with the law violators we are attempting to reach. By relieving him of the duties imposed on him as a member of the governor's staff, he will undoubtedly feel more free to offer advice to said parties with less personal embarrassment."

Word was received this afternoon by Governor West that Colonel Lawson had notified the half dozen saloons in Huntington to give up their slot machines and other gambling devices by this evening so that they could be shipped to Baker. The saloon men agreed to have them ready.

The saloons at Huntington will not be closed but the owners will get warning that if they allow gambling they may expect more trouble.

Governor West this morning extended the olive branch to Baker county, but the branch was held in a mailed fist.

The governor wired Sheriff Rand as follows:

"Whenever you will assure this office that you will co-operate with us in putting a stop to

further violations of the liquor laws in your county and closing all houses of prostitution we are ready to withhold any further activities on the part of the militia. As a pledge of co-operation we ask that you appoint F. H. Snodgrass as deputy sheriff for 60 days without pay to assist our officers in performing the above duty. An early reply will be appreciated."

Snodgrass is one of the head guards of the state penitentiary.

READS THEM THE LAW.

Anticipating that Sheriff Rand might attempt to arrest Colonel Lawson for contempt of court for ignoring an injunction, the governor sent the following telegram to Circuit Judge Anderson, Sheriff Rand and District Attorney Godwin:

"Section 3774 of the code provides no person belonging to the military forces of the state shall be arrested on any civil process while going to, remaining at or returning from any place at which he may be required to attend for military duty. Section 3855 provides members of the militia ordered into the actual service of the state by any proper authority shall not be liable civilly or criminally for any act done by them while on duty. We are advising Colonel Lawson to govern himself accordingly."

Fruitmen to Build.

The Umpqua Valley Fruit Growers' Union, which was organized less than a year ago, has decided to erect a large warehouse in Roseburg before next season's crop is ready to market. The local fruit growers' union is affiliated with the North Pacific Distributors' Association.

Those of us who thought we were through registering last year find that we have only begun. But if we would exercise the right of citizenship this is the first step.

Open Winter Predicted.

The miners and other mountaineers on the higher levels in the Cascades say that the deer and "varments" are going back to the high mountains, which they say is an indication of a further open winter, such as the fore part of the season has been. Every year these animals come down to the lower country, where there is seldom any snow, but this year as there has been little snow on the higher mountains and by instinct they seem to know when there is to be colder weather in future, they are returning to the summit.

Long Session of County Court.

The county court convened in regular monthly session Thursday. This session will be longer than usual for the reason that the court will have to appoint the road supervisors, select the circuit court trial jurors for the year, appoint the judges and clerks of election and finish up the old year's business.

Roseburg Dancers Restrained.

Roseburg's modest dance ordinance, which was framed with a view to eliminating objectionable dances, passed the city council last week after a spirited debate. The ordinance is similar to that in operation in Portland, its enforcement being in the hands of the police.

NEW TAX LAW THE WORST EVER

Few people of Lane county are acquainted with the new law regarding the collection of taxes. Those who have taken the trouble to inquire about its provisions are quick to see the unjustness of the law which was passed by the last legislature. The general opinion is that this law is about the worst that was ever passed by that body.

By request, Attorney-General Crawford has interpreted the law as follows:

"First, all taxes are due April 1. Second, if not paid April 1, all that remains unpaid bears interest or penalty at 1 per cent per month for five months, to-wit: Until September 1; that is, if paid within 30 days after April 1, 1 per cent; if paid after 30 days and within 60 days, 2 per cent, and so on, 1 per cent being added each month for delay.

"Then September, all unpaid taxes become delinquent, and the 1 per cent a month is added to the delinquent amount September 1. If not paid September 1, then on that day 10 per cent penalty is added to the amount computed before. In other words, the original tax and 15 per cent would be due at that time, and then that full amount draws interest at 12 per cent per annum until paid."

Moving to Eugene.
