### Gets \$20 a Month Pension

WASHINGTON, D. C., Aug. 13.—Through the efforts of Representative Hawley and Senator Lane, Congress recently passed a bill granting a pension of \$20 a month to Dr. William W. Oglesby, of Cottage Grove, who served as Captain of Company G, Second Oregon State Militia, in the Bannock Indian war in 1878. Dr. Oglesby's pension is the first ever granted by Congress for injuries received in Indian wars that occurred subsequent to 1856. All other Indian war pensions that have been allowed by Congress are on account of service covered by the existing Indian war pension laws.

"While serving in the Bannock war," says the committee report, "Dr. Oglesby was engaged in battle with hostile Indians July 6, 1878, at Willow Springs, Or., where he was wounded in the right knee, the bullet being still lodged in the joint. He is now 76 years of age, severely crippled by reason of his wound, and is practically incapacitated for manual labor. The occurrence of the wound while in battle with Indians is proved by the testimony of an officer and a comrade, both of whom served with him, and the existence of disability is equally well established.

"Captain Oglesby has never made a claim for pension at the Pension Bureau for the reason that the existing laws do not cover his case. He was not mustered into the military service of the United States, and furthermore no provision has been made for pensioning any of the volunteers of militia who served in any of the Indian wars in which this country has been engaged since the close of the Civil War.

"He is worthy and deserving of relief."
