A \$35,000 damage suit which may last several days in the circuit court was commenced Tuesday in the case of Luthur B. Hudson, against the Brown Lumber company, of Cottage Grove. The alleged accident is said to have occured almost two years and a half ago. The plaintiff claims that he was permanently crippled by the accident which is said to have injured his spine and caused a nervous disease. He was struck by a piece of timber while working in the mill. The lumber company contends that the permanent injuries were caused by other things, and that the man went to work in the mill again after the accicident.
