We cannot recall an utterance of our late President that will bear so universal praise as his last public speech at Buffalo the day before the cruel hand of an assassin struck him down. It strikes the first note in the death knell of radical high tariff policies and on this account will be a valued legacy to the American people he said;

"Our capacity to produce has developed so enormously and our products have so multiplied that the problem of more markets requires our urgent and immediate attention. Only a broad and enlightened policy will keep what we have. No other policy will get more. In these times of marvelous business energy and gain, we ought to be looking to the future strengthening the weak places in our industrial and commercial systems, that we may be ready for any storm or strain.

"By sensible trade arrangements which will not interrupt our home production, we shall extend the outlets for our increasing surplus. A system which provides a mutual exchange of commodities is manifestly essential to the continued and healthful growth of our export trade. We must not repose in fancied security that we can forever sell everything and buy little or nothing. If such a thing were possible, it would not be best for us or for those with whom we deal. We should take from our customers that of their products as we can use without harm to our industries and labor. Reciprocity is the natural outgrowth of our wonderful industrial development under the domestic policy now firmly established. What we produce beyond our domestic consumption must have vent abroad. The excess must be relieved through a foreign outlet and we should sell everywhere we can and buy wherever the buying will enlarge our sales and productions, and thereby make a great demand for home labor. The period of exclusiveness is past. The expansion of our trade and commerce is the pressing problem. Commercial wars are unprofitable. A policy of good-will and friendly trade relations will prevent reprisals. Reciprocity treaties are in harmony with the spirit of the times; measures of retaliation are not."

The Baltimore Sun declares "the speech is a frank confession that the country has outgrown its Chinese Wall tariff policy," while the Boston Herald remarks; "If the president had given utterance to such opinion a few years ago he would have been denounced as a free trade heretic."

It is gratifying to note that the last public speech of President McKinley to say the least it was uttered in the spirit of an enlightened political age, conservative, in accord with the best interests of the people and tacitly recognizing the fact that "protection for revenue only" must hereafter be the policy of this government.

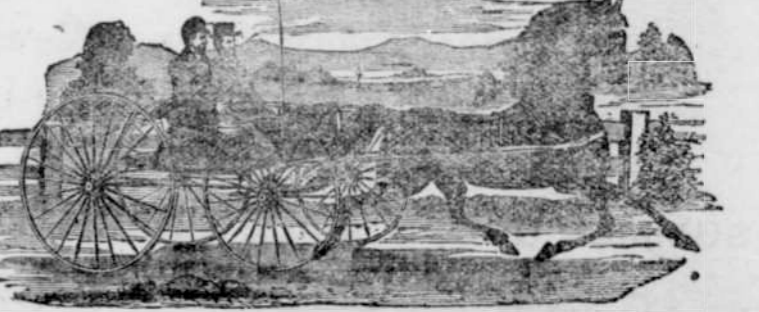
