An Eastern syndicate has been represented here by an expert to put on two special properties. He is very much pleased with the rock formations in this district, and the character of the ore bodies found, and with abundance of water all through the district for milling purposes.

Mr. Galbrath of the Lake Shore Mining Co., has just returned from the mines. The ledge shows fine croppings for a long distance, and prospect well. They are working on the vein 180 feet from the surface, showing it is from 4 to 8 feet wide which assays well.

They have drifted on the vein over 272 feet all in pay ore while part of the lead runs very high. This amount of development work gives them abundance of ore to start a mill, still they keep a night and day shift opening up the mine. Just at the foot of the hill there is a small lake that will furnish sufficient water for milling purposes, so that a mill can be located near the mine at the lowest possible cost.

DIED.—John Kuykendall, a pioneer of 1852, died at Drain, August 15, after a lingering illness, aged 75 years. He came to this coast in 1852, traveling part of the way in the same train with the late D. R. Christian, of this place. Arriving in Oregon, he stopped one winter at Milwaukie, moving from there to what is now Wilbur, in Douglas county, where he lived for twenty years, taking an active part, with Father Wilbur, in founding the old Unquappa Academy and maintaining its existence through many trying years when it was the only school in the state of high grade south of Eugene, or perhaps Salem. Afterwards he removed to California for a few years, but returned to Oregon in 1888, engaging in the drug business at Drain, where he has resided since except about one year when he resided in Eugene, being engaged in the grocery business on Williams-street where the Christian block now stands.

John Kuykendall was one of a group of early comers who made it a credit to be called a pioneer of Oregon. His kind is rapidly passing away and but a few straggling gray heads are left of the young men of noble character and high purpose who came west to build up homes, found a commonwealth, foster education and make the land "where rolls the Oregon" something more than a sounding name. He was a man of whom all who knew him may say, "A good and just man has gone to rest." A widow and one daughter and seven sons survive him. Of these Mrs. A. Pickering, of Fort Omaha, Neb., Dr. G. B. Anderson, of Pomeroy, Wash., Rev. J. W. Kuykendall, of California, Dr. W. Kuykendall, of this city, and E. W. Kuykendall, of Grant's Pass, were at his bedside during his last illness.—Eugene Guard.
