H. T. Morrison, who ter consultation with leading brethren, the Committee employed Bro. Morrison to labor in the county until the present meeting, agreeing to remunerate him for his labor, at the ratio of \$1000 per year. Bro. Morrison has been at work wherever an opportunity offered, and has labored acceptably as we think in several places in the county, as that the minutes of this meeting, in will appear more fully from his re-

Now, dear brethren, the duty devolves upon you to say whether you will keep Bro. Morrison or any other man in the field for another term and sustain him by your counsel, sympathy, and also by which he will be engaged.

Resolved, That the Christian people of the Apostolic age were more devoted than at the present time. It was then moved and seconded that Bro. Samuel Baughman lead in the discussion as above stated subject. Motion prevailed.

11. Miscellaneous. Under this head there being no apparent business Bro. Gill introduced the prospects of the Christian spiritually and financially. Quite a number of the brethren and sisters engaged in some very touching remarks on this subject.

It was now moved and seconded a condensed form, be sent to the CHRISTIAN HERALD. Motion prevailed.

12. Motion to adjourn the business part of this meeting, to convene at Pleasant Hill, Lane county, Oregon, on February 24, 1884. Motion prevailed. The business your means in the arduous work in part of the meeting was then adjourned by Bro. Cheetham.
