Current Oregon law requires public notices to be printed in a newspaper whose readers are affected by the notice. Many government agencies in Oregon believe that posting public notices on their web sites instead of in the local newspaper will reach the public more effectively.


But who would have access to those online notices? 62% of U.S. seniors (65 and older) have no internet access, and a third of those who DO have access are still limited to dialup.\*

Besides, you'd have to know in advance where, when, and how to look, and what to look for, in order to be informed about government actions that could affect you directly.

Less than 10% of the U.S. population currently visits a government web site daily, \*\* but 80% of all Oregon adults read a newspaper at least once during an average week, and 54% read public notices printed there.\*\*\*
