Promoters of Portland Southern Railway Expect to Begin Grading in Thirty Days.

The promoters of the double-track electric railway to be built between Portland and Salem declare that the work will be completed and cars running over the line within the next twelve months. The company is also considering the advisability of building side lines to Dallas and Silverton as feeders to the main line. The following interview with L. B. French, one of the promotors of the road, appears in Thursday's Salem Statesman:

"Yes, I think at the latest, twelve months from now will see the completion of the road from Portland to Salem," said Mr. French. Our people mean business, and are ready for it. The money is ready. We know where it is coming from for the construction of the road, so we are not worrying at all about other people who doubt."

"When will you begin work, Mr. French?" was asked.

"We were ready to put our engineers at work on Monday," was his reply; "but I find we are now liable to have to change our route on account of some right of way questions. One or two men are holding out, in the region beween Brooks and Salem, and it may be possible we may cut across the Southern Pacific tracks at Lake Labish and come up on the west side of the Southern Pacific line. We are offered right of way there, and also some other inducements, if we desire to take them."






