ACKERMAN ISSUES ORDERS

State Superintendent Makes Public Information Concerning Eighth Grade Examinations.

State Superintendent J. H. Ackerman has issued an order relative to eighth grade examinations in the state during 1909, for the following dates: January 21-22; May 13-14; June 10-11, and September 2-3.

The program of examinations will be as follows: Thursdays—Arithmetic, writing, history and civics; Fridays—grammar, physiology, geography and spelling.

The sources from which the questions are taken and in which preparatory study may be made to advantage by those intending to take the examinations, are given as follows:

Civil Government—United States Constitution. Geography—State course of study; Redway & Hiram's Natural School geography.

History—List of topics from History Outline in state course of study and current events. Language—Buehler's Modern English Grammar, no diagramming.

Reading—The teacher will send to the county superintendent the applicant's class standing in reading, which shall be taken by such superintendent as the applicant's standing on the subject.

Spelling—Eighty per cent from Reed's Word Lessons, and twenty per cent from manuscript in Language.

Writing—Specimens of penmanship as indicated in copied matter and from manuscript in Language.

Advertisements under this head are charged at the rate of 1 cent per word, first insertion; 1/2 cent per word for each insertion thereafter. No advertisement inserted for less than 12 cents.

Figures count as one word. For instance, the numeral combination "250" counts as one word.

Two initials count as one word. For instance, "W. M. Jones" counts as two words.

The minimum charge is for 15 words; that is, an advertisement from 1 word to 15 words is counted as 15 words; an advertisement from 16 to 20 words, inclusive, is counted as 20 words; from 21 to 25 words, inclusive, is counted as 25 words.

The figures following the advertisement indicate how long it is to run, and are not charged to the customer. For instance, 3-12-23 indicates that the advertisement was first published on March 12, and that it is to be inserted until the 23rd of that month.

The figures and letters 4-1-1 indicate that the advertisement was first published April 1 and that it is to be run until the customer orders it discontinued.
