Salt For Dairy Cattle.

Cows having salt kept before them all the time will not eat too much, but they may be overfed with salt if they have not been given any for a long time. The salt stimulates the appetite and increases the flow of body fluids.

A Forcing Effect.
Fresh manure has a forcing effect and tends to produce stems and leaves at the expense of fruit and grain. It is therefore better for early garden truck, grasses and forage plants than for cereals or fruit.
