THE NATION'S LOSS.

Oregon had no more loyal or powerful friend than Harvey W. Scott, whose death from heart failure occurred at Johns Hopkins hospital in Baltimore, Maryland, Sunday evening, following a surgical operation for prostaticity. Thoroughly familiar with the history and growth of the state; knowing its needs, its resources and its advantages as only the editor of its oldest and greatest newspaper could know them, no one other than he was in a position to render such influential and effective service in the advancement of its material welfare. Fully appreciating this position of power and responsibility, Mr. Scott devoted his great talent and his best energy to the upbuilding of every part of the state he was proud to call his home. The value of this effort, covering a period of forty years, cannot be overestimated when one considers the growth and development in every line of industrial and commercial endeavor. Himself a pioneer, and a son of pioneers, his friendship and neighborly feeling for the men who endured untold hardship and privation in rescuing the Oregon country from the wilderness was one of the marked traits of his character. Any matter of interest to pioneers; any mention of noteworthy events in the social life of those sturdy men and women always found a welcome place in the columns of his newspaper. While leading the progressive thought and action in the development of the state, his kindly feeling toward the early settlers was ever cherished by Mr. Scott, and to the end his dearest friends were to be found among the acquaintances of his boyhood and young manhood. As a newspaper editor, Mr. Scott has been aptly described as "a two-fisted fighting man." From this description, however, it must not be gathered that he was a contentious or quarrelsome nature. His fights were for principle; seldom with men. Of an intensely practical mind, he had no patience with fads or chimerical theories, either in social life or in the administration of government. He was a sturdy champion of decency and morality, but an uncompromising foe of intolerance and fanaticism. He was a "two-fisted" fighter, but he fought a fair, he gave no quarter, and he was none. With characteristic broad-mindedness, however, he was ever ready to give the widest publicity to the opinions of those who might happen to differ from him, and the columns of the Oregonian were always open to friend and foe alike. Mr. Scott was an editor of the old school. He exercised a close supervision over the various departments of his newspaper, and it is every column breathed his personality. Like Greeley and Dana, who preceded him to the Great Beyond, and like Watterson, who survives him, Mr. Scott enjoyed a national reputation for his individual influence in journalism. One who had been his friend and admirer paid a graceful and merited tribute to the dead editor when he said: "During his life he was a capacity for larger labors, as well as an intellect richly endowed, if he devoted this life occupying a place of national honor in his chosen field, it was because he was willing to spare delights and live laborious days."
