PREPARE FOR POULTRY SHOW

Great Display of Fine Birds Will Be Seen in Dallas Next Month. Printing of the entry blanks for the annual Poultry Show to be held in Dallas, December 13-15, was completed yesterday, and the blanks, accompanied by the rules for exhibitors, are being mailed today by Secretary B. I. Ferguson. Liberal cash prizes are offered in all divisions, and the officers and members of the Polk County Poultry Association will spare no effort to make the coming exhibition the greatest display of blooded poultry ever seen in Polk County. Chickens, ducks, turkeys and geese will be admitted to entry. It is probable that the greatest interest in the show will center about the silver cup offered by Postmaster J. E. Beazley, of Falls City. This handsome trophy was won last year by Mrs. J. E. Northrup, of Lebanon, but in order to become the permanent property of the exhibitor, it must be won three times. Competition for the "mag" was great last year, but it will doubtless be keener than ever this year. The poultry raisers of Polk County are entitled to much praise for their efforts to stimulate and promote a highly profitable industry, and it is hoped that every breeder of blooded birds in the Willamette Valley will prepare a display for the coming show. Appointed Good Roads Delegate. M. B. Grant, mail carrier on Rural Route No. 2, leading out of Dallas, has received notice of his appointment as a delegate to the Oregon Good Roads Convention, to be held in Portland, Monday, December 13. This convention will consider Good Roads legislation for the State of Oregon and it is expected to make important recommendations to the next Legislature. SPIRITED TEAM RUNS AWAY

Sheriff Grant Meets With Exciting Mishap in West Salem. Sheriff John Grant and a Deputy Game Warden who was riding with him were the victims of a lively runaway accident in West Salem yesterday afternoon. Luckily, both officers escaped with nothing worse than a ducking in the cold water of a ditch at the side of the road. The horses escaped without injury, but the cover on the buggy was badly wrecked. Sheriff Grant had been serving papers all morning in the Eola Hills country and was driving into Salem for lunch when the accident occurred. A Deputy Game Warden, whom he had overtaken on his way to Salem and who had accepted an invitation to ride, was in the buggy with him. As the officers were driving through West Salem, one of the clips holding the tongue to the axle gave way. This mishap frightened the horses and caused them to run. Sheriff Grant clung to the reins in the hope of bringing the plunging and kicking animals under control, but the remaining clip soon gave way and the buggy was overturned. Sheriff Grant was thrown into the icy waters of a ditch at the side of the road and the Game Warden landed squarely on top of him. After bounding around in the water for a few minutes, both men regained their feet. Sheriff Grant was wet to the skin and the Game Warden was plastered with mud from his head to his feet. Notwithstanding their predicament, the two officers laughed at one another until their sides ached. They then set off after the lost team. One horse was found entangled in the harness and hung up on a tree a few feet from where the accident occurred. The other horse had stripped himself clear of the harness and had run quite a distance before being captured by residents of the town. Little damage was done to the buggy farther than the complete wrecking of the top. Sheriff Grant proceeded on to Salem, got his lunch, and returned to Dallas with the team last night.
