

POPULAR TEACHER WEDDED TO BE ADVANCED TOMORROW

Miss Marietta Phillips Becomes Bride of T. C. Husted, of Heppner.

Amid a sumptuous setting of beautiful flowers and in the presence of a large number of relatives and friends, Miss Marietta Phillips and Thomas Husted were married at the home of the bride's parents, Mr. and Mrs. T. D. Phillips, a short distance west of Dallas, last Wednesday evening at 4:30. The ceremony was performed by the Reverend D. M. Metzger, dean of the faculty of Dallas College. The bride was attended by Miss Alice Grant, as bridesmaid, and the groomsmen were Ben Phillips, youngest brother of the bride, and Robert Husted, of Portland, and Robert VanOrdel.

Following the ceremony, Miss Laura Husted sang "The Sweetest Story Ever Told," Miss Maggie Evans played a wedding march. An elaborate supper was served on the broad veranda of the Phillips home.

The bride is one of Polk County's most charming young ladies. For five years she has been a highly efficient teacher in the public schools here, and is a host of friends who will wish the same couple every joy. The groom is a prominent resident of Heppner, and expects to remain here to participate in the Phillips family reunion which will be held at the Fourth, and will then move to their home in Heppner.

Good Hay Crop.

The rain of the past three days has been of immense value to the hay growers of this state, as it insures a crop of timothy and grain hay, as a rule, being cut, however, suffered, probably 50 per cent of it being damaged by the rain. The loss will be more than made up by the increased yield of the other kinds, says the Oregonian. No new hay has reached the market yet and it will be two or three weeks before new crop timothy is available. Several cars of alfalfa are on the way to this city and will arrive a day or two. In view of the good crops, dealers do not believe prices will be as high as last year, and the prospecting that has been done, therefore, is on a lower basis. The old crop that remains, is in strong hands and is being cleaned up at fairly good prices.

Rains Injurious.

The rains have been injuring the very crop of Western Oregon, but damage from the Eastern section thus far has been reported, says the Portland Journal. The damage is most due to the fact that the fruit is usually beginning to ripen in the Yamette Valley. The crop in the valley this year is very small, and now with additional damage from the rains, it is not believed that the market output will be a quarter of the normal. Receipts from Oregon in Portland are still very small. Shipments from The Dalles fully as great as during any previous season at this time. Quality is best in years, and for that reason sales continue high.

Salem Masons to Build.

SALEM, June 28.—It has become publicly known that the Salem Masons will construct a six-story building at State and High streets, and an architect has been retained to draw plans for the new building. The first floor will be used for store purposes and the upper floors for offices and lodge rooms. The building probably will cost \$100,000.

Loganberries Will Be Short.

LAKE LABISH, Ore., June 27.—Loganberry growers face a certain crop shortage this year, because the rains failed to branch out for this berry's crop. Contracts are being made at 1 1/2 cents a pound. Picking not yet begun.

APPLE PRICES TO BE GOOD

Prospect of Fairly Good Output in Northwest This Year.

The fruit growers and dealers of the Northwest are now much interested in the apple crop and market outlook, and from this time on that subject will claim a good deal of their attention. In a general statement bearing on the present situation and the prospect for the future, W. B. Glafke, one of the leading local dealers, said Wednesday to a Portland Telegram reporter:

"While the government report on apple crop conditions in the country generally for June make a rather unfavorable showing for California and the Pacific Northwest, as compared with that of 1910, it should be remembered that this report indicates the condition of the crop at the date of the observations recorded, and is not necessarily an index of the size of the yield. In all probability the apple crop of the Northwest this year will be materially greater than that of last year, for the acreage bearing this season is considerably above that of any previous season."

"The prospect is for a fairly liberal output in the Northwest this year. There will be apples enough, but at the same time the growers may rest reasonably sure of good prices for all good grade fruit they can get to market. Good apples are invariably good property and there is far more danger of a shortage than of an over-supply of that sort of fruit. As to the apple trade with the Orient this year, it is too early yet for any definite statement. The markets across the Pacific, as in the past, will be taken care of so far as we are able to supply them."

FOR CHERRY FAIR VISITORS

Reduced Round Trip Railroad Rates and Special Train Service Given.

Manager Louis Gerlinger, Jr., has announced a special train service and reduced round-trip rates for the benefit of excursionists from Polk County to the Cherry Fair, to be held in Salem, Thursday, Friday and Saturday, July 6, 7 and 8. The late train leaving West Salem at 11:15 p. m., Saturday, July 6, has been arranged especially for those who wish to take in the carnival on that night, and will give everyone a chance to see everything and still get home in time for a good night's sleep.

The following round-trip rates are authorized to West Salem from the stations named:

Thursday and Friday, regular trains only will be run, but No. 6, the west-bound train, will leave West Salem at 5:35 p. m., instead of 4:35, as at present.

Saturday, in addition to the regular train, a special train will be run, leaving West Salem at 11:15 p. m., for Dallas, Falls City and Black Rock. The final return limit of tickets will be Sunday, July 9. The usual free allowance of baggage is authorized on regular tickets, and children of half fare age will be carried at rates shown above.

RECORD BISCUITS ARE MADE

From Kansas Wheat Field to Mouth in Thirty Minutes.

BELOIT, Kansas, June 28.—Biscuits ready to eat made from wheat that was standing in the field just 10 minutes before, is the record made by W. S. Gable, a farmer living near here.

The header was driven into the wheat field at 3:14 o'clock. One minute later the wheat in the straw was at the separator. A quantity was threshed, loaded into the farmer's automobile and at 3:23 was at the mill. Six minutes saw the wheat come out as flour, and a minute later the automobile was distributing flour at a downtown bakery. Fourteen minutes later, at 3:44 o'clock, the biscuits were removed from the oven, baked and ready to eat.

Cherry Fair Biggest Ever.

The Salem Cherry Fair this year will surpass any three-day carnival ever put on in Oregon, and is billed for July 6, 7 and 8. The big civic and industrial parade takes place Thursday; the automobile parade Friday; the comic parade Saturday evening. For each of these hundreds of dollars in prizes are offered, and the baby parade Saturday forenoon has another hundred dollars in prizes for the best babies and the best decorated go-carts, home-made baby trucks, and lighted city perambulators. The Oriental feature will be a \$250 float. The German Society will have a \$100 float drawn by six white horses. The lodges and state institutions and the Indian School from Chagawa will have special features. Fire department, Salem police, King Bing and Queen Anne, the clowns, the hoboes and the country fiddlers will be there. The Capital City is sending out 5000 cherry postal card invitations extending the hospitality of the Cherry City of the World to their personal friends, far and near. It will be a home coming day for all who have ever lived in the city of peace and prosperity. The cherry show proper will be at Marion Square, around which will be grouped the Arnold Carnival attractions. Thursday noon will be the occasion of the Iowa market picnic, when all Hawkeyes will assemble at their annual reunion.

Father of Fifteen.

EUGENE, Ore., June 27.—Louis D. Gibson, one of Lane County's earliest pioneers and the father of 15 children, died at his home in this city yesterday at the age of 82 years. He is survived by his wife and 11 of the children, scattered in different parts of the state. He was born in Warren County, Missouri, February 11, 1835, and came across the plains to Oregon in 1849, settling in Lane County. He was married in 1854, and reared his large family of children on a farm west of Eugene.

WANT PORTLAND-SALEM ROAD

Governor West Names Committee and Plans Use of Convict Labor.

George F. Rodgers of Salem, Grant Dimick of Oregon City, and C. T. Prall of Portland, were Wednesday appointed a committee of three to make plans for using convict labor on a proposed road from Portland to Salem. The members of the committee are from the three counties through which the road will be constructed. They will co-operate with the county courts, and it is hoped that within a short time the plan will be made effective. A good public highway is very much needed between the two cities and it is expected that the plan of Governor West will meet with favor.

In speaking of the matter, the Governor said Wednesday:

"The building of such a highway would demonstrate what could be done with convict labor. The reason for selecting this particular piece of road is mainly that it would connect the state capital and the state metropolis and is close to the convict labor, which is to be used. Besides the road from Salem to Portland is as bad as any road in the state with equal traffic. The kind of road to be built is to be left to the committee."—Salem Statesman.

PENSION BASIS PUZZLES

Salem Man Wore Barrel as Punishment in Civil War.

SALEM, June 27.—Harry E. LaMar, of this city is endeavoring to secure a pension under peculiar circumstances and has secured a number of affidavits from former officers of the Civil war to substantiate his case. So far it is shown LaMar has traveled under three names, the first one being Scrip, later changed to Henry E. Gilbert, and now to LaMar.

According to the affidavits LaMar or Scrip was with the army following up Hood after the battle of Nashville and, proving incompetent, Captain Horton of the company, had a hole cut in the bottom of a barrel and the barrel fastened over Scrip's head. According to the affidavits LaMar was one of the greatest foragers in the army. The alleged unusual punishment inflicted on the man is cited as one reason why a pension should be granted to him.

LAKES TO BE RESTOCKED

26,000 Young Trout Taken to Mountain From Springfield.

SPRINGFIELD, Ore., June 27.—Twenty cans, containing 18,000 young lake trout, have been taken from here to Summit Lake, 100 miles from here, in the Cascade range, where they will be distributed in an effort to restock that lake and other mountain lakes. Eight thousand fish of the same kind were also sent by automobile to Triangle Lake, in the Coast range.

The fish were sent here from Oregon City, where they were hatched from eggs shipped from the East. Drew Griffin and George McClain, of Eugene, are the men who have undertaken to take the young fish to Summit Lake. The fish must be kept in fresh water, changed several times daily, and the cans must be kept on ice. The fish for Triangle Lake were taken there in a few hours by W. A. Kuykendall, of Eugene.
