THREE TOWNS IN FIRE BELT
 Mill City, Gates and Niagara Ask Help of Salem.

ALBANY, Or., July 26.—Fires are still raging in the timber belts south of Mill City and in the vicinity of Gates and Niagara, and according to reports received here this morning are entirely beyond the control of any ordinary fire fighting force that can be assembled. Several ranchers have been burned out and families in several cases barely escaped with their lives. It is stated that Niagara is nearly encircled by blazing forest. Campers and farmers in that locality have been compelled to flee for points of safety. No life loss has as yet been reported.
 Urgent calls for assistance have gone in to the state forestry department at Salem from several points that are threatened. One hundred and fifty employees of the Curtis lumber company are aiding a considerable force under the direction of forest rangers in confining the fires, but the work has been of little avail. The section already burned over is several miles in extent, and the fire is now in a tract of green timber. The underbrush is extremely dry. The destruction of many farm buildings together with crops seems probable.

Bridge This Year.

CHOOSE POLK FOR LOCATION
 Portland Firm to Establish Model Dairy Across From Salem.

Pinekey Bros., of Salem, have recently purchased the Clover Leaf Dairy farm, consisting of 50 acres, located at the west end of the Salem steel bridge, in Polk County, and formerly owned by Mr. Heise. These gentlemen have had years of experience as practical dairymen and it is their intention to equip and conduct a sanitary dairy second to none in this or any other state.
 W. E. Pinekey, who is the managing partner, has been until recently general freight agent of the Chicago Great Western Railroad Company, with offices in Chicago, and comes to the Pacific Coast to make his future home, and join his brothers in operating a model dairy farm.
 Mr. Pinekey states that they have selected Salem for their operations, says the Statesman, as there seems to be a demand for a strictly sanitary dairy here, and the Heise farm offers an ideal location. Pure, clean, unadulterated milk will be furnished from the start, and as soon as possible the present buildings on the farm will be remodeled, yards paved, silos constructed, and modern methods of feeding adopted, all of which are factors in making possible the production of certified milk.

SALEM COUNCIL DEADLOCKED
 Squabble Over Question of Replacing Washed Out City Bridges.

SALEM, July 25.—Salem's peculiar deadlock over the question of replacing the nine washed-out bridges is growing more hopeless. Mayor Louis Leuchman tried in vain to break the combination last night. In one representative case the property-owners are spending \$50,000 on hard surface pavements on a street which is cut in two by a bridgeless stream. The other streets are in similar condition. The city has no money to build bridges and a political combination is preventing a bond issue.
 Shortly after the floods of last spring swept the city's bridges away the proposition to vote bonds to replace them was put up. Election day caught the people in the needy sections napping, and the bonds failed by 22 votes. Again the proposition was submitted. Twice the former vote was polled and the bond issue lost by 44 votes, the same ratio. An ordinance was introduced to submit the bond issue to the voters in the form of a charter amendment so a majority vote would carry. This ordinance was defeated in council July 17. Mayor Leuchman made another strenuous effort to have it reconsidered and passed last night, but failed.

ASKS FOR GOAT SHOW
 COMMERCIAL CLUB WOULD HAVE EXHIBIT HERE.

Indorses Move to Hold Prune Fair in September—Comments Band Concerts.

Two popular exhibits of Polk County's wonderful resources are to receive the backing of the Dallas Commercial Club this fall and winter, according to action taken at a special meeting held Wednesday night. An effort will be made to obtain the annual show of the Northwest Angora Goat Association in January, and the club will also undertake to launch the first Polk County prune fair, with the purpose of making it an annual institution.
 Ava L. McDonald, of Portland, secretary and treasurer of the Goat Association, was present and asked the club what it was willing to do in order to have the show brought here this winter. He called attention to the fact that Dallas was the center of the Angora goat industry, and mentioned the benefit of the advertising which would be given throughout the press of the country. It would not only be a great advantage to the growers of this county, but would bring in large numbers of the most enterprising and prominent breeders from all over the Northwest and from the East and South. A large and comprehensive premium list would be offered by the Association.
Vote Favored Dallas.
 G. W. McBea, of this city, chairman of the executive committee of the Northwest Association, was present, and stated that a straw vote taken at the last meeting showed that Dallas received the unanimous vote as the choice for the next show, and he was anxious to see it brought here.
 After some discussion, on motion of W. L. Soehren, Secretary Toozie was instructed to notify the Northwest Angora Goat Association that the club would furnish a suitable building and pledge a substantial amount of money for necessary expenses.
 A motion to appoint a committee of three to visit upon the great breeders of this county, to ascertain what they were willing to contribute in addition to the amount to be given by the club, was made by H. A. Woods, and Mr. Woods, Edwin Jacobson and W. L. Soehren were appointed.
Extend Formal Invitation.
 The Association is to hold a meeting at the State Fair in Salem this fall, and the following committee, with President A. B. Muir as chairman and Mr. Woods as secretary, was named to extend a formal invitation to hold the show in Dallas: U. S. Loughary, J. Riley Craven, D. P. Patterson, U. S. Grant, Edwin Jacobson, Tracy Staats and G. W. McBea.
 The question of promoting a prune fair for the county, to be held in Dallas in September, was taken up, and on motion of N. L. Guy the idea was indorsed, and a committee, consisting of the following prune men was appointed to begin the preliminary arrangements: H. A. Woods, H. S. Butz, H. G. Campbell, R. L. Chapman and Secretary Toozie.
 Mr. Woods, in urging the advantages of such a display, said that Polk County would be able to provide the fair, and that it would not be necessary for her to go to Marion County to get the prunes, either.
Better Train Service.
 The subject of getting direct train service on the Oregon-Washington Railroad & Navigation Company from Dallas to the union passenger station in Portland was broached, and on motion of W. L. Soehren, the secretary was instructed to take the matter up with the railroad company.
 In appreciation of the popular series of band concerts which have been rendered weekly on the court house plaza by the Dallas band, the Commercial Club voted to extend the concerts throughout the remainder of the summer season. It is understood, however, that this will be impossible, as the members of the band are anxious for a vacation, and practice will be discontinued until after hop picking and the busy fall work is over.
