CAN IT SUCCEED?

The main concern of the Bullmoosers now is to implant in the minds of the people that their "party" is not a "one-man movement." They are having all manner of trouble in this respect. Eighty per cent of the men who have enlisted under the banner of the third-term have little idea of the platform of his party.

Can a movement founded upon so insecure a footing, whose paternity is the personal ambition of an unskilled and insane demagogue for perpetuation in power, be successful in this country? Are the American people ready to desert time-tried and tested institutions and methods which have given unexampled prosperity and stability to this nation and made it the greatest on earth, merely at the behest of one individual whose over-powering and dominant egotism is his one overshadowing characteristic? We do not believe it.

England and Canada are peevish at the action of the senate in standing by American shipping and legislation that coastwise ships should pass free of tolls through the canal. They are so worked up about it that they may withhold their support from the coming Panama exposition at San Francisco, according to reports. Well, let them do so. It is not likely that the threat will be taken seriously, either in this country or in Canada or England. The British nation is well aware of the advantages of exhibitions of this nature, and if it elects not to be represented, that is its affair. If it can afford to ignore the great world's fair, upon so flimsy and selfish a pretext, its action will reflect upon the common sense of English and Canadian people more than upon the United States. The passage through the canal of American coastwise vessels free from toll charges is of vastly more importance to the United States than the question of whether or not English and Canadian exhibits should be at San Francisco. The great majority of the American people probably don't care a hoot whether these countries patronize the fair, but they do care that American shipping be given this advantage over vessels of other powers. They are entitled to it, and the American people have earned this concession in return for the money the canal will have cost.

Senator Robert M. LaFollette is still rapping Roosevelt, and declares in the current issue of LaFollette's Magazine that the colonel is not interested in the success of the progressive movement, only as it affects him personally. "How do you stand on this?" is Roosevelt's sole test of qualification for progressives. He imagines that a progressive candidate can be elected on this basis, but of course it would be reactionary. Roosevelt is not concerned about the question of an Aldrich senate, or a Cannon house, but he is just as satisfactory to him if he could win more easily with that kind of a combination. No dispassionate observer will deny the truth of the above statement. No one who has followed the course of the colonel will deny that it's anything to win with him. It is not so with LaFollette. He has been consistently upholding progressive principles since long before his present "leader" had embraced the faith. He has secured all sorts of alliances and combinations which might have helped his cause, because he has been steadfastly fighting for a principle. A few months ago, when he was in the senate, he declared that he is "too radical" to be entrusted with the reins of government, but they have since forgotten about it in viewing the antics and extreme radicalism of the would-be King of the United States. Governor West has become a terror to the evil-doers in the cities and towns of the state where the lid has a habit of tilting badly at times. His extreme measures in cleaning up Huntington, have sent cold chills down the backs of officials in several other towns, and there is noted a feverish desire to wipe out the dark spots. No town or city is any worse in this regard than it seems to be, and the officials charged with enforcement of law are active or otherwise, according as public sentiment in their communities dictates. Huntington,

with its gambling dens and open saloons at all hours, was exactly as the majority of public sentiment wanted it. The town with no-license laws governing it, and with blind pigs in operation, and open and flagrant violation of the law of frequent occurrence, could easily stamp out this sort of thing if the people who opposed it were in the majority. Under these conditions, then, if the plague spots are to be eliminated, it is an outside influence that will have to do it, and Gov. West appears to be the man of the hour.

Ben Selling, Republican candidate for United States senator, is out in an address to the voters of Oregon in which he defines his position in the presidential contest, and declares that he will support President Taft. The dominant feature in the Selling statement is its evident sincerity. Mr. Selling declares himself as one of the first progressives in Oregon and says that he is still fighting for, and believes in, those principles. He abruptly pipped; I admit one key - cracked by calling attention to his record in the state legislature, and in the political campaigns in Multnomah county, that he has done much to give Oregon its advanced form of government. He declares that President Taft is a progressive and, as such, is entitled to the support of every honest believer in progressive ideas. Mr. Selling's statement is clear, concise and frank, and will result in securing for him the support of the Oregon Republicans.

Now that the dates for the fall Harvest Festival and School Fair have been decided upon, it is up to every citizen of Dallas to do what is possible to make the affair a success. Especially should there be a comprehensive display of farm products and fruit. Polk county has no superiors among the counties of the state in this regard, and steps should be taken at once to see that the best is on display. That the school portion of the exhibit will be in every way worthy of the "blue ribbon school county of Oregon" is already assured—let us see to it that the display of products of the soil may be something to be proud of.

Efforts of the Democratic spellbinders and newspapers to annul the LaFollette support for Candidate Wilson are ludicrous in the extreme. With much satisfied effrontery it is claimed that every last one of the Wisconsin senator's friends will vote for Wilson in an endeavor to "further LaFollette's progressive ideas." Just how they figure that a vote for a Democratic candidate will help the Wisconsin man, is not evident. Senator LaFollette has declared that the only way to secure the triumph of his progressive ideas is to work within the party rather than to flock to the standard of Roosevelt. If this be true how, then, can it be accomplished by deserting the Republican party and voting for Wilson?

The rumpus in the Oregon National Guard has become a disgrace to the soldiers of the state and should be speedily forgotten. The actions of the general staff and of the adjutant general and their childish antics over the disbandment of the Second battalion is becoming distasteful to the people generally, who know little and care less about the matter. Politics dominate the National Guard, it is declared, and the general staff has done its part to bear out this assertion. What is needed in Oregon, it appears, is a disbandment of the general staff.

A Newport newspaper complains that the Carson Wild West show, which recently visited Toledo, didn't advertise in Newport and thus appalled the people of its coming, in order that they might attend. The Newport people shouldn't lose any sleep over the show's neglect, especially since the principal stunt in connection with the show appears to be the adeptness of some of its attaches in short change tactics and of its hangers-on in flammaging the public.
