The Hen That Lays Is Hen That Pays. The Sun has before spoken of the success of the Kerr Bros. in their poultry business, and it now has the result of their efforts for the year just closed. They are not in business in a magnified form, but rather work to excel in a small way with the result that they know no failure. Their flock is kept at about 100 fowls, and from this number they secured from January 1, 1912, to January 1, 1913, 16,100 eggs, equal to 1341 dozen and eight eggs. For these eggs they received an average of 30 cents a dozen, making a total of \$492.30. From the chickens sold they received \$123.20, making the total receipts from the flock of 100 chickens \$615.50 for the year. They have no trouble to make the hens lay, and on New Year's day they gathered 31 eggs. They give preference to the single-comb white and brown leghorns. W. L. Kerr is the poultry specialist and his work is more for pleasure and pastime than as a great poultry raiser. He enjoys it and knows the "how" and that is probably the secret of the whole business.—Sheridan Sun.

LEGISLATURE HAS HARD TIME TO KEEP GOING

this regard. The opposition to the resolution, if it was genuine, cannot be questioned, but the same tactics have always been employed heretofore by a certain few who never lose an opportunity to take a whack at some measly little appropriation which gives them an opportunity to play politics, but they forget all about their economic scruples and help to vote large sums of money away in extravagant appropriations. A man should endeavor to be consistent even if a member of the legislature. And these men may be all that—time alone will reveal. There will be plenty of opportunity to vote away the people's money, too. Senate Bill No. 1, by Joseph of Multnomah, calls for an appropriation of \$250,000 to aid in making an exhibit of the state's resources at the fair, and provides for the "appointment of a commission" to look after it. And this commission will probably spend the most of the money, too, in high salaries for a half dozen sleek-fed officials who will begin to serve immediately after the passage of the bill, and continue to act until a year or two after the fair is over or the money gives out. The people of Oregon want the state to exhibit at the San Francisco fair, but they do not want their money frittered away in expensive preliminaries and unfruitful salaries.

A joint resolution has also been passed relating to the proposed interstate bridge over the Columbia river, which it is proposed to build for the benefit of Portland by the states of Oregon and Washington, and it is highly probable that the promoters of this idea will attempt a raid on the treasury to aid the project. There is going to be plenty of opportunity for the economists to get into action before this session shall have passed into history.

Polk to the Front.

Polk representatives in both houses fared well in the appointment of committees. In the Senate Hawley was made chairman of the important committee on education, a position for which he is eminently fitted, and he is also a member of the committee on agriculture, game, printing and ways and means. In the House Brunk heads the committee on agriculture, and is a member of the education and livestock committees. Verd Hill drew places on the committees on food and dairy products, manufactures, military affairs and salaries of public officials.

Fire Works on Tap.

While there hasn't been any spectacular outbursts so far, they are liable to come at any time, especially in the senate, where Senators Joseph and Kelaher, the firebrands from Multnomah, are continually on the watch for something to hit. Both realize that they cannot hope to accomplish much at the present session, where the majority opposes them, and they will make the most of every opportunity that arises to have a merry time with the same majority. Senator Ira Smith, of Coos and Curry, is a hard-working member and is always on the job. He says he is here to do business and is endeavoring to carry out that precept to the fullest extent. He is a former Polk county resident and is well known in Dallas, and in fact all over the county by the older citizens. He says he has a warm spot in his heart for "old Polk."

is ripe for a cannery. Manager Peterson of the Armory plant was reported as saying that if the city wished to have a cannery the company would make arrangements to include this department with their packing plant, and asked that farmers guarantee the planting of 40 acres or more of loganberries as a guarantee of good faith, and a general cannery would be forthcoming. The Armory plant, according to statements made, is willing to place a cannery in the city as soon as there is the necessary amount of fruit.

The county fair appropriation matter had a short hearing and it was suggested by Chairman Loughery that the appropriation should be made at an early date, if any was to be made, and he believed that an expression from people in various parts of the county would assist the committee materially in determining the general sentiment. H. C. Seymour was appointed as a committee to feel the pulse of the people outside of Dallas.

EATS AND FLOPS UNPAID COURT HOUSE PICK-UPS

Officers Capture Careless Guest at Independence; First Case For New Deputy Prosecuting Attorney.

On complaint of Landlord Kelly of the Hotel Dallas, J. Peterson was yesterday arrested by the city marshal of Independence and will be arraigned before Justice Holman this afternoon. The arrest was made by instructions sent by Sheriff Grant to the Independence officer. Mr. Kelly, the complainant, asserts that Peterson obtained board and lodging at the hotel of which he is proprietor to the amount of \$10.75 and that he surreptitiously removed his baggage from the hotel. The case is the first one to be prosecuted by Deputy Prosecuting Attorney Toose. The penalty for this crime in Oregon is not less than \$20 and not more than \$300. It is understood that defendant is making an effort to settle the matter and cut down the expense of a trial.

COUNTY COURT PROVIDE HOME

Destitute Girl Finds Friends in Court Procedure.

Commitment of Beniah C. Jackson, dependent child, aged nine years, was today made by the county court, upon petition of O. Sherwood. The girl will be sent to the Boy's and Girl's home at Portland in charge of Sheriff Grant.

From the petition filed the facts show that the girl was without parental care and was in need of the support of the county officials.

The commitment will give the Portland society full authority to pass the young lady to a permanent home and the order of the court may result in finding a permanent abiding place for the one reported destitute.
