SHOULD PROFIT BY STREET WORK NOW DONE

(Continued from page 1.)

find the total cost to be about the same as the careful and wide-awake towns are paying for their hard-surface pavement.

Cheaper Elsewhere.

"Only a few evenings ago I had a talk with a traveling man who had just finished paying his paving assessments on a number of lots in a well-known Oregon city. He exhibited receipts showing that one lot of paving had cost him \$1.65 a yard, and another kind of finish \$1.45 a yard. These figures represented the total cost of grading the streets, laying the rock foundation, and putting on the smooth top dressing. This work was done in outlying additions, where only a comparatively small amount of paving was done, and this property-owner informed me that the heavy and expensive portion of the improvement was encountered in the grading of the streets and the construction of the foundation.

Big Kick May Come.

"Here in Dallas we know something of the cost of opening a rock quarry, installing a crushing plant, hauling rock a distance of three miles, surveying and grading our streets, and laying a macadam foundation. Were we inclined to forget this expense, I think our individual street assessments and the present 12-mill city tax levy would serve to refresh our memories. If the smooth-surface pavement is to be laid on our existing macadam streets, and an outside paving company is to be saved all of this expense, I predict that a right healthy and effective kick will be registered if any attempt is made to compel the property-owners to pay this cost a second time.

Sure to Come.

"As to the outcome of the present agitation for paved streets, there can be no doubt. The improvement is sure to come. Even those who stubbornly persisted in forcing through the unprofitable and unsatisfactory macadam program, when a majority of property-owners in the business district were crying for hard pavement, are now joining in the demand for modern streets, and as the rest of us have never changed our minds as to which improvement would have been better, it begins to look as if a vote to "make it unanimous" will shortly be in order.

"And this is as it should be, for Dallas cannot hope to keep pace with the march of progress unless this all-important improvement shall be carried out without farther delay. We are proud of our town's advanced position in all other lines of development; we positively cannot afford to remain behind in this.

Must Safeguard Interests.

"But we must proceed with circumspection, if the interest of the property-owner is to be guarded and extravagance avoided. Let the slogan be: "Every business street in Dallas a paved street before the end of 1915, and hard-pavement in the residence district whenever a majority of the property-owners ask for it."

But when some outside corporation comes along and asks us to pay again for a rock foundation that we have already bought and paid for, let's tell them that historians note the fact that the year we were born into the world, the sucker crop was small.

interests of the state, and it is intended to protect the stockmen from the importation of diseased animals from other states. It also provides means for fighting all diseases of hogs, cattle and sheep, and had it been in operation last fall, would have proved a formidable weapon in fighting the scourge of hog cholera that swept over the Willamette valley. When Governor West approved the bill, following the 1911 session, he is said to have admitted that he did not understand it fully, and it is declared that its passage over his veto is a matter of no concern of his. It is hoped that the bill will pass and become a law.

Notes of the Session.

Salem's lone cafeteria on State street is a popular eating place with the members of the legislature and the employees. Here senators and representatives mingle with clerks, stenographers and pages, in an effort to get at the "eats" each noon-time. The cafeteria is a great leveler of rank; all meet here upon a common level, and grabbing a platter and a package supposed to contain the implements of warfare upon the roasts, join the hungry line that moves incessantly past the steaming provender.

"Gimesomeothat," shouts a dignified senator, while "I believe I'll have some of the soup," murmurs a demure "Steno," at his elbow. "What's that?" inquires a fat representative, pointing an inquisitive finger at a new-fangled mess of something-or-other, almost hidden in a cloud of steam. "That's r-r-rumpty-ste-m friesees," says the attendant, brandishing a fork. "Gim me some of it," orders the fat one, and he shoves along to the next notch. On Wednesday, shortly after his election, Senator Lane joined the long line of hungry legislators at the cafeteria and, with "the common people" shoved his tray along the line with the others. "I'll have some of the cauliflower," remarked the newly-made senator. "We're out," replied the assistant.

"Well, then, gimme porkandbeans," that's pretty good," remarked the statesman from Multnomah, as the appetizing dish of Boston grub slid on to his tray. Just like the rest, and not a bit swelled-up over his new honor, Senator Lane heaved to the call of the inner man and got in the grub line with gusto.

Many of the senators are lovers of the apple, and hardly a half hour goes by during the session that one or more of them are not munching the fruit. Senator Miller started it, but others have followed suit, until the apple dealers of Salem are figuring on sending their fruit up to the capitol by the dray load. Senator Hawley joined the throng and has a whole compartment of his desk filled with the bright red fruit from Polk county. It is needless to say that the vicinity of his desk is a popular resort during the intermissions.

President Malarkey is an ideal presiding officer. He states all propositions fully and completely and in a clear tone, in order that all senators may be fully advised upon all subjects but, even at that, every now and then some senator who has been busy "gassing" with a constituent, will meekly inquire "What is this upon which we are voting? I didn't catch what the chair said." The president also rushes business, and occasionally intimates that debates will be to get shortened "if we expect to get through with our business."
