Official Ballot Is Six Feet Long

Salem, Or., Oct. 11.—Without any county officers or county or precinct initiative measures attached, the state ballot will be exactly six feet long. The ballot will probably come from the hands of the state printer tomorrow for distribution and certification to the various county clerks.

In many counties the ballot probably will go to eight feet at least and it is believed that the ballot in Multnomah county will be fully nine feet long. In many precincts and counties there will be local initiative measures tending to swell the length of the ballot considerably.
