'TIS SOMETHING MORE

The battle of ballots for the reinstatement of the State Normal School, at this place, has been fought and the victory won, but with the achievement comes responsibility which must be met.

Monmouth, as a country village, without the state institution, was different from what she is with the normal school located within her borders. Under the former condition she had interests as a town to look after, and while it was very much to her credit to move forward in improving her streets, side-walks, beautifying the town, and reaching out after improvements, yet it was not so imperative that her citizens should do so as it is now, especially in improvements and sanitation.

With the normal school comes state interests and the pride of the commonwealth of Oregon is placed to a large extent in the keeping of her citizens.

The town now becomes important as a state representative and her citizens should see to it that the place is put in order so that those who come here to prepare themselves as educators will find surroundings congenial to study and progress and of such character as will lend moral influence and energy to them.

The attention of the whole state will be upon Monmouth and we will be judged by what we do, and success or failure will be largely be due to the efforts put forth by the citizens of the town. Of course it will cost money and labor and thought to put our town in proper condition to merit the trust imposed upon us by the voters of this commonwealth, but who ever attains to a worthy object without sacrifice?

As we have said before the streets will need attention and our side-walks are out of repair, while there must be something done toward better sanitary conditions, and one of the most important wants of the city is better water facilities. We labored for the prize and won out, and now that the attainment is ours we must meet the conditions that come with it in order that we show our appreciation, and put ourselves in the way to profit by what is given us. Every dollar we spend in improving and beautifying our holdings adds to their value, and all the labor we lay out upon them comes back to us as a reward of our diligence, hence we will be the gainers though we may have to sacrifice in order to improve.

As a means to better sanitation we must have septic tanks or a sewer system and in either case the water system will have to be extended and a more bountiful supply secured, so as not only to secure the wants

already mentioned, but to give better security from fire also.

These things are up for our consideration so let us face them with confidence and a determination and energy that will triumph over all the obstacles that stand in our way.

Just watch and see Monmouth grow!

A long pull; a strong pull, and a boost altogether for Monmouth.

Monmouth won her normal school, but since Ashland and Weston lost, many of our citizens think the victory was only half won.

The registration in Oregon showed some 81000 Republicans and 26000 Democrats, or nearly a proportion of four to one, yet a Democratic governor was chosen. Surely partizanism is losing its hold.

Now that Roosevelt won out in his fight against the stand-patters in New York, and the Democrats have won out against Roosevelt and his backers, it begins to look as though Rooseveltism is on the wane, and foreshadows his elimination from presidential nomination in 1912. Roosevelt has wielded the "big stick" with terrific force but is himself caught in the rebound.

That the millennial reign is not yet here is indicated by the tone of our exchanges although there are those who claim that we are passing through that blissful period. However we are inclined to think that those making that claim never read all shades of newspapers during a heated campaign, for if they had they certainly must have been converted to the error of their belief.

The two Monmouth precincts were loyal to Ashton and Weston on the normal school question giving to each a vote nearly equal to that for the Monmouth school, but in the county the other two schools suffered defeat, while Umatilla and Jackson counties gave majorities for the Monmouth normal. The heavy vote against the Ashton and Weston Normals is the more surprising when we consider the comparatively small amount of expense necessary to maintain these schools. The cost of one cigar or one drink of beer, during the year, if abstained from, would be more than sufficient to pay the amount asked by either school from each individual as an average of those who opposed the schools.
