### Fined for Selling Adulterated Milk.

Pleading guilty to the charge of adulterating several gallons of milk sold to a Portland dealer, W. J. Domes, of McCoy, was sentenced to pay a fine of \$25 and costs, taxed at \$8 additional in Justice Hardy Holman's court in this city Saturday morning. Domes paid the fine and was released.

The complaint was sworn out by F. G. Stiller, deputy food commissioner, and specifically declared that Domes had shipped to the Damascus Creamery, of Portland, a large consignment of milk which was too liberally mixed with water. Domes was arrested Friday by Sheriff Grant. —Dallas Observer.

### Fire Drills in Public Schools Are Urged.
