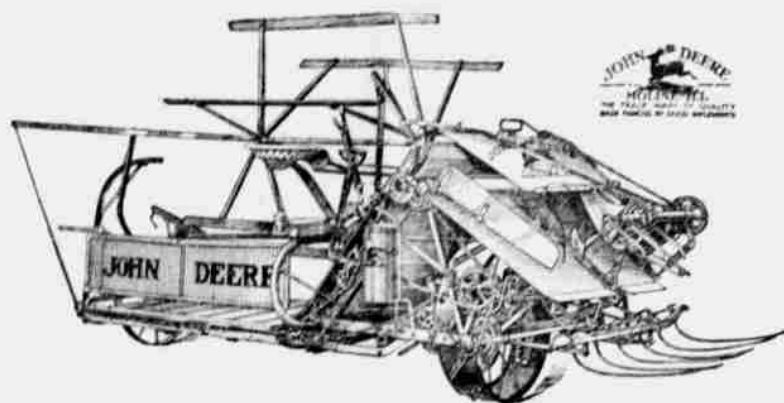

Fire At Independence
