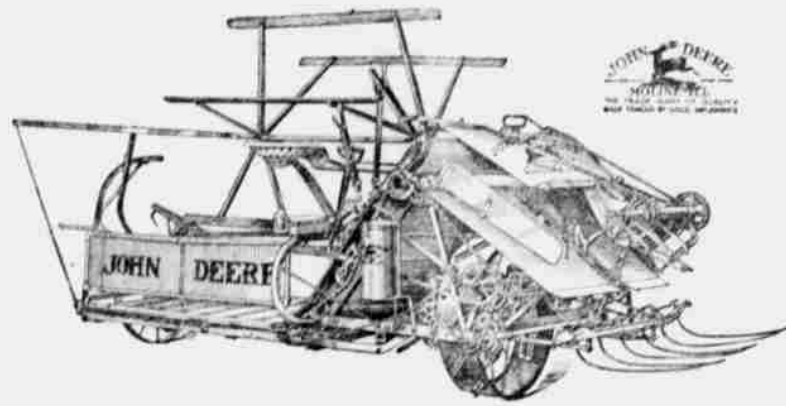

Will Move Away

Monmouth is going to lose one of her good citizens, or rather a small family of citizens, as J. K. P. Carson has traded his four-acre tract here for H. W. Polk County Will Test Widow's Pension Law

Is one county liable for the payment of a widow's pension to a woman who was not a resident of the county at the time the act

occurred that otherwise would have qualified her for a pension?

That is a question which the circuit court will be called on to decide at the coming session, in the case of Maude Ena Zachary vs. Polk County.

Mrs. Zachary, whose husband was committed to the state penitentiary on April 18, 1914, from Marion county, moved to Polk county two days later to reside with relatives. She is the mother of five minor children, all of whom are dependant upon her for support.

Under the law which provides that mothers of dependent minor children whose husbands are dead or are inmates of public institutions of this state shall be paid a pension by the county in which they reside, Mrs. Zachary applied for such relief from Polk county, but her petition was rejected by the county court at its May session. Mrs. Zachary, through her attorney, Oscar Hayter, has brought suit to compel the court to grant the pension as prayed.

This is said to be the first case ever brought in the state to test the widow's pension law, and upon the outcome will rest the important question of whether or not a woman must continue to reside in the county where she became a widow or otherwise dependent to be entitled to the benefits of the law.—Itemizer.
