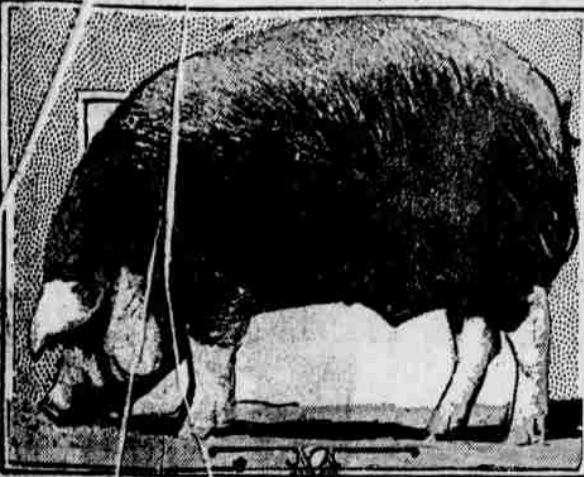
To Elizabeth Richardson, the defendant above named:
