## TAKES MAYOR FROM SALOON

CHIEF OF POLICE ESCORT HIM

"Feform" Executive of Capital City and Fellow Hop Dealers Loath to Leave

SAL M, Cr.—After opening the adminstrator in the role of a reformer, Mayor Lathmund with Kola Neis, Conrad Krebs, Juli a Fiacus, of this city, and men giving the hames of Georie Wilson and Arthur Anderson, of Portland, whree taken o'clock aunday morning by Chief of Police Hamilth after they had been warned a number of times by Patrolman Cooper to leave. The ordinance here provides that sa oons shall close at 12 c'clock midnight.

No definite action has been instituted by the Chief of Police in relation to their cases and after he had ordered them from the saloon he allowed them to leave for their homes. Considerable secrety was maintained in regard to the affair and news of it did not become known until Sunday. It was with the greatest relicence that the Chief of Police was persuaded to tell of the occurence.

It is said that the men were singing and enjoying a revelry which
caused the police officer first to
remonstrate. They paid no attention
to Patrolman Cooper and again he
remonstrated after which he called
the attention of Chief Hamilton to
the circumstances

"I sm not positive just what action I will take in the matter," said the Chief of Police, "Because Mr. Lachmund is Mayor is no more reason why he should escape prosecution under the ordinance than any other preson. But there are several ways of arriving at the result in this affair and so far I am unable to say just what I in end to do in the way of filing charges. So far the men have not been arrested."

The Marion Hotel paid a fine of \$25 in court for keeping its bar open after hours.

Messrs. Lachmund, Neis, Krebs and Pincus are all prominent hop dealers here and are known all over the state. Kola Neis recent y returned from a trip to Germany and was welcomed with open arms on his return. He is prominently connected with hop interests on the European Continent, where he frequently visits. Krebs is owner of one of the larges hop ranches in the world, this being situated near Independence. Lacamund is also a hop dealer of considerable prominence and owns ranches in the Valley as well.

Chief of Police Hamilton and City Attorney Grant Corby engaged in a long conference on the subject, but the result of their interview was not given out. The Chief of Police is an elective officer, while the City Attorney receives his appointment from the Council.

When the administration first went into office the Chief and the City Council locked horns over the rejection of Larry Murphy, who had been on the police force for several years. Chief Hamilton wanted to reject Murphy, but the Counil voted to retain him over the head of the Chief.

Murphy resigned and quited the trouble, but considerable ill fee'ing developed at the time which established something of a factional difference. Whether this will have any influence on Chief Hamilton's action at this time is not known.
