It is given out that \$50,000 is available for the Willamette and Yamhill rivers this year. It is time some of these "available" appropriations for the Willamette were available. "Available" appropriations avail nothing as long as mountainous sandbars are permitted to rise to tickle the salmon bellies in the riffles and stumps and snags raise their defiant heads in the river channel. With all past "available" appropriations boats are able to make the year round, no higher up the river than Salem. Only a little dredging and the removal of a few snags and the river would be navigable to Independence, twelve miles farther up the river, twelve months out of the year. Only a reasonable amount of dredging still further up the river, and boating would be easy to Albany Corvallis and Eugene. People of the upper river fondly hope to see a reasonable portion of the \$50,000 they tell us is ours expended in actual dredging where dredging is actually needed this year. Having been promised it so long, we are over anxious to see what a government dredger looks like. We have read of the heavy content of the millions expended by the government for jetties and dredging at the mouth of the Columbia; how hundreds of thousands are being contributed by both state and national governments to get over the Cascades at The Dalles. We have witnessed the decaying remains of old jetties at Yaquina Bay that cost a round million and benefits nobody. The Long Tom, Coos Bay and places of lesser importance have had a friend in court while people of the Upper Willamette Valley are paying 50 cents a ton and 10 cents a head to a private corporation for everything that goes out of the valley in addition to the higher rates that go with an undredged river.

Before the munificent sum of \$50,000, all told, is expended, the people demand to see that puffing, belching, government dredge at least as high up the river as Independence.

The University of California will open a six weeks summer session at Berkeley, June 26. The corps of instructors will be made up of some of the leading educators of America and Europe. In addition to the regular course, primary, grammar and high school grades will receive attention. Oregon's \$300,000 worth of state schools might receive a suggestion from the enterprising spirit exhibited by the California University. The summer sessions at Berkeley advertise both the school and the country. It tends to make friends for the school among the educators of the country, who in educational matters should have some say rather than throwing schools upon the mercy of politicians. It lies within the power of state schools, to a degree at least, to lift themselves from the rut of barter among legislators. By

demonstrating that its work in the cause of education is indispensable to the state at large, the legislative politician and "log-roller" will be frightened off.

Independence has entertained a detective the past week, employed to run down the dog poisoner. Up to the time of going to press, the dog poisoner is still at large though no dogs are reported poisoned since Friday. As usual in such cases, there are suspicions, rumors and guesses the latter of which should be omitted altogether. The poisoner has put out of the way a number of worthless curs and with them killed a number of valuable dogs and by the promiscuous scattering of bologna sausage over town, endangered life among children. To lay the guilt at any one's door is a serious charge and should not be made unless there is convincing and convicting evidence. The names of some reputable citizens, who could not and would not have had anything to do with dog poisoning, have been mentioned in connection with the affair. This reckless use of names is wholly unnecessary and the sooner dropped the better. It breeds no good in the community.
