

NO NEWS FROM PEKIN.

Chinese Cut Communication of Allied Troops --No News Since 17th.

A \$50,000 SLEEPING CAR ROBBERY.

BOONE, Iowa, August 23.—Near here this morning masked robbers entered the railroad sleeping car in which Cashier Balch of the Omaha National Bank was traveling. Cashier Balch was assaulted and robbed of \$50,000 in currency which he was conveying to another bank.

No clue to the identity of the robbers has been obtained.

NO COMMUNICATION WITH COAST.

SHANGHAI, August 23.—The consuls here have received no communications from the commanders of the allied troops since August 17.

It is probable that the allies have not been able to keep their line of communication with the outside world open on account of the length of the line to be guarded and maintained.

The absence of news causes no little uneasiness. Twenty-seven warships with crews aggregating 7000 men are assembled in Shanghai.

ANOTHER CENTER OF DISTURBANCE.

SHANGHAI, August 23.—The prevalent disaffection has spread to Haknow, and outrages on foreigners and destruction of their property is reported.

Hankow, the great commercial center of trade of the middle portion of the Chinese empire, and open to foreign trade since 1858, is situated on the Yang-tse-kiang river about 450 miles west of Shanghai, and at an elevation of 150 feet above sea level. Estimates of the population vary from 400,000 to 800,000.—ED GUARD.]

An immense throng was present to witness the formalities, and the enthusiasm reached fever heat.

Bryan fully discussed all the national issues. He insisted that the government banks should not have the exclusive privilege of issuing the money of the country.

Thousands could not reach the sound of Bryan's voice although he spoke in good voice and form.

FIRST SCALED PEKIN WALLS

Calvin Pearl Titus, a Spokane Boy, the Musician of the Fourteenth Infantry.

SPOKANE, Aug. 22.—Calvin Pearl Titus, a musician of the Fourteenth Infantry, the first American to scale the walls of Peking and to hoist the Stars and Stripes, is 29 years of age. He was reared by Evangelist William Lee, now preaching here.

Titus' last letter said: "The trouble is good in China so we may not have a bad time; but this regiment knows only one way to go—that is forward."

"I am for Bryan heart and soul, and shall do all in my power to help elect him. McKinley has been a failure. He has no backbone and is completely under the control of Mark Hanna. I like Bryan because of his honesty, his integrity and because he is one of the common people."

Apples for China Trade.

Consul Harry B Miller writes H B Doch, of the state board of horticulture, that Oregon apples should find a market in Shanghai, his piece of refuge during the enforced absence from his consulate. He writes in part:

"Yakima apples come in here every year and sell for \$7 silver per box, or \$3.50 gold. A good market could be had here for the Oregon apples if they could be sold for \$2 gold per box. I see no reason why the line of steamers out of Portland could not take up the matter and make business. Several varieties of Oregon apples should do well here."

Other Sufferers.

The crop failure in the lower Umpqua valley is so pronounced this year that grain will have to be imported, says A E Ozout, of Scottsburg, in the Roseburg Review. The principal farmers above Scottsburg altogether have not more than 9000 bushels of wheat, and what they have is unfit for market.

On Smith river, near the coast, the cutworms ate up the pastures and this will handicap the hitherto profitable creamery business in Gardiner. However, most of the farmers are well fixed, and will be able to stand the loss of a year's crop. Fishing and lumbering will continue to give employment and circulate money.

Where Pearl Comes From.

The pearl fisheries of the Red Sea extend the whole length of that water. About three hundred boats are employed by the Arab tribes, manned by crews of from five to twelve men, each provided with a number of small canoes. NEAR WENDLIN

Lumber Will Be Hauled Out On Railroad Cars By September 1.

A RAILROAD STRIKE

WENDLING, August 23.—The track-layers on the Southern Pacific branch railroad from Springfield to Wendling are now within two and one-half miles of the latter place.

Track-laying has been delayed by a strike. Forty men of the experienced track-laying gang went on a strike last Saturday and quit the company employ. The remaining force lack experience in this line, delaying the work to a considerable extent.

The Southern Pacific give out that the lumber output will be hauled out as soon as the track is completed to Wendling but passenger and mail trains will not be put on until the roadbed has been surfaced and graveled.

Roadmaster Wait has assumed charge of the branch road and has been examining the same during the past few days in order to get an intelligent understanding as to the needs thereof.

HELD FOR CIRCUIT COURT.

Walter J. Shelley Bound Over in the Sum of \$250.

Daily Guard August 23.

Justice C A Wintermeier this afternoon concluded his review of evidence and finding of fact in the preliminary examination of Walter J Shelley, held yesterday, and bound the young man over to appear before the next session of the circuit court in the sum of \$250, which was furnished by J M Shelley, his father, and H A Vincent.

The case is well remembered. Two weeks ago while Shelley, then night clerk of the Hotel Eugene, was going to the depot at 3 o'clock in the morning to find out the time of trains, he claimed to have been held up opposite the Minnesota House and robbed of \$90, one \$20 bill and seven \$10 bills, which had been entrusted to him by a patron of the house. He at once notified the officers, and Policeman Croner went with him back along the line finding a torn envelope a block off the street containing two \$10 bills. Shelley has advanced the theory that the man who gave him the money, and others put up the job to relieve him and then collect the amount from the hotel, at all times maintaining his own innocence. Holtenbeck Bros refused to pay the amount over to the patron as they had given absolute instructions to Shelley to receive no money from patrons for safe keeping.

Suspicion, all of a circumstantial nature, pointed to Shelley, as being the man guilty, as I have been carefully watched since, and was placed under arrest yesterday, charged with larceny by bailies. All his purchases and expenditures have been closely watched, and the kinds of money passed out inquired into, and upon circumstantial evidence he was detained.

Shelley was with the Second Oregon in the Philippines, but was sent home disabled, having become blind from the effects of measles. Major Ellis operated on him, and since, he is virtually gained full control of his optics. The young man is well connected and considerable interest has been taken in the case.
