ROCK CRUSHER WORK.—Cottage Grove Nugget: The county rock crusher has again been moved from near the cemetery on Silk creek to a location on James Hawley's place near the Divide, where it has begun crushing and will continue at it until the necessary repairs are made in that direction. It has done good service on the road to Siuslaw and the travel that passes over that road this winter will be greatly benefited for the repairs made.

CRUSHED BETWEEN LOGS.—Last Thursday Charles Sinclair, while working in a logging camp near Walterville, was badly crushed between two logs, dislocating his right thigh and injuring him internally. Dr. B. F. Russell was called and reduced the dislocation and attended to his other injuries. It will be several months before the man will be able to work again. He is poor and has a large family. The county should help him.

MORE FALSEHOODS.

The Oregonian Stands Self-Convicted.

Under the head of "In the Empire State," he says: "No Enthusiasm at the Bryan meetings." Then read the accounts of Mr. Bryan's meetings at every place and you will see the editor of the Oregonian stands self-convicted as a falsifier.

At Rome, N. Y., it says: "His audience at that place was large and attentive, and the speech was punctuated with frequent bursts of applause."

At Oswego, N. Y.: "The Oswego meeting proved one of the greatest triumphs of Mr. Bryan's tour. It was a reminder of his best Ohio meetings. There were probably five times as many people present as could hear what was said. Mr. Bryan spoke for only about half an hour. He mounted a table so that all could see. Referring to the size of the crowd, Mr. Bryan said he had wasted a good deal of time in visiting other places, 'not knowing that the whole state would be in Oswego.'"

At Syracuse, N. Y.: "The return trip to Syracuse was made in an hour, and this city was reached at 8 o'clock. A cold, drizzling rain which set in early in the evening did not dampen in the least the ardor and enthusiasm of the immense crowd which gathered to greet Mr. Bryan when he arrived. The crowd was practically the largest which has greeted a political speaker here for many years. The crowd jammed and squeezed itself into the large square fronting on the Erie (usual) pocket dock. Mr. Bryan spoke from a stand erected in front of the Westinghouse opera house. Inside the theater there was a mass meeting, which was addressed by Mayor Jones, of Toledo, until Mr. Bryan finished his open air speech. He spoke for half an hour from the stand, and then went into the theatre and spoke for an hour and a half."

INTERESTING LETTER

Philippine Affairs as Seen By a Soldier.

INSURRECTION NOT BEING ENDED.

The following letter from the Philippines, written by Jesse B. Lawrence, bugler of Company K, Thirty-fifth Infantry, U. S. V., to Chase Griffin, will be read with interest not only by Second Oregon men, but by the many friends of Bugler Lawrence, who is a Eugene boy. It is one of the best letters the GUARD has ever published from the islands:

SAN MIGUEL, Aug. 21, 1900.

"As you see by the heading I am stationed at San Miguel de Mayumo. San Miguel has a population of about 21,000, and is said to be next to Manila. Some of the companies of the Second Oregon were through this town in one of their campaigns, but I do not know what companies. We are about 22 miles from Malolos.

"In reaching Manila our regiment took the train as far as San Fernando, and came to this place. When we reached here there was not a gun to be found. This is supposed to be on the north firing line. Of course we were very much disappointed, for then all the fighting was on the south line. But now we have our share and perhaps more.

"The mountains near here are just full of insurgents. The consequences are, many come through here. The regiment has just been called in from a 22 days' run through them.

"Part of the time General Funston and four companies of the Twenty-second and four companies of the Macabebes were with us. Funston is all O. K. if he is from Kansas. If the United States had had a few men like him over here at the first of the outbreak this thing would have ended long ago.

"I read by all the papers from home where things are progressing nicely in the Philippines and that the war is virtually at an end. The people in the States are kept very ignorant of the progress of things over here. For a while things were very quiet but as soon as the rainy season commenced the insurgents assembled in small bands and attacked detachments, that were scouting the country, and firing on small garrisons. Finally they were driven to the mountains, where, with the number of American soldiers that can be had, they are safe. Of course we can drive them from their positions whenever they make a stand, but they will never stand unless their number of men is double ours. Some places we have found them very strongly entrenched, but we could always run them out by a flank movement.

"When I say 'we' I mean the different companies that garrison this province.

"Bulacan, the name of this province, is a very large one, having, I believe, 12 towns, which towns are garrisoned entirely by the 35th. The province also extends through these mountains so you can readily see what we have to do. Three companies of the third battalion garrison this place and at one time there were only 60 men for duty. I do not mean to say the rest of the men were sick. Quite a number are on detached duty.

"I suppose you have heard of Biñan, at one time Aguinaldo's stronghold. My company garrisoned that place for six weeks. It is right in the mountains and only about six miles from this place. The people here told me that was always considered a place of safety when the Spaniards were trying to take this town. Finally the Spaniards got possession of this town and also Biñan, and it is said at one time the Filipinos captured 800 and wounded 400 Spanish soldiers out in that little 'hole in the wall,' as we called it. There are places at Biñan, where 20 American soldiers with plenty of ammunition could hold off a regiment of insurgents.

"Aguinaldo is said to be in a very well fortified stronghold some place in the fourth range of mountains from here under the name of some general. Two American negroes and one hospital man were held as prisoners where they say Aguinaldo is. They were set free about two weeks ago.

"Our regiment has been very lucky. It has lost but few men. I have been in a few skirmishes only, but the Mauser and Remington bullets have whistled just as close as I wished them to. I was a little nervous at first, but soon became accustomed to it.

"Some think the war will end after election. They say if Bryan is elected he will give the Filipinos their freedom, and if McKinley is re-elected the Filipinos will try to resist no longer. From the way things are going on now, I actually believe that if McKinley does still hold the presidential chair, the Filipinos will still hold their arms. They will not be satisfied unless they have their freedom.

"I have held conversation with some of the smartest men in this town,

in which I have asked them why they still fight against the Americans when they know it is impossible to whip them.

"Their reply has been this: 'Until the election in the United States for president we only intend to keep a small body of men organized to harass or torment the Americans, just to let them know that they are still resisted by the Filipinos, and that we, the Filipinos are fighting for our independence.'

"I asked them what if Bryan was not elected, but I could get no satisfactory answer.

"I think the United States will need more than 50,000 soldiers over here to quell the Filipinos or she will have to use them rougher than we are compelled to use them at present. For a while we had to call them our 'Little Brown Friends.' These Filipinos have been treated good long enough to know what the American people are, and yet they will not lay down arms. I say it is time to use a different plan and go right in for business. Burn some of their towns. I know it hardly seems right, but is it right to have our men sacrifice their lives year after year, and get no satisfactory result obtained? If we would let them know we mean business and are tired of beating around the bush, and burn some of the main insurrection towns, why they would soon be compelled to come to terms and be glad to. Then we can show them what America can do for them.

"Only a few months ago a Mauser rifle was captured that was made in 1899. So you can see they are getting and can get new guns.

"Not long ago Captain Roberts, of I company, and three of his men were captured. Colonel Tescon held him as a prisoner. Several consultations were held between the colonel and his staff and Lieutenant Colonel Walsh, and some officers of this garrison. They met about eight miles from here, the Americans numbering about 20, while the insurgents' number was not known. After the place was decided upon by letter, the Americans marched to it and laid down their arms. Presently Col. Tescon and his staff and about 30 men appeared. They were friendly. Captain Roberts was allowed to come. They had not been there long until insurgents could be seen on all sides, many of them coming in and talking to the Americans. They had all kinds of rifles; some had Mausers, some Remingtons, while many had a 16-shot Winchester. All of their guns were in good condition, many looked new.

"You can see by this that we are fighting against regular soldiers and not bands of ladrones, as some of the American papers print. Whenever they capture some of our men (that is of late) they take their guns, ammunition, shoes and part of their clothing and parole them and send them back to town. Although or first duty sergeant has been captured about a month, we have heard nothing from him.

"The president, vice-president and two other big bugs of this town, are in the 'calaboose,' by order of general headquarters. The president was found to be a recruiting officer. The people of this place are all insurgents. Of course they do not all carry guns, but they are insurrection sympathizers, and aid them in any way possible. Around town they are 'muchachos.' Naturally, for they are making more money off of the Americans now in one month, than they did in one year before the Americans occupied their towns.

"The Thirty-fifth should receive the credit for the capture of Gen. Pilar. This is the way it happened: At Malolos, where some of the Thirty-fifth were stationed, three well-dressed Filipinos, surrounded by about 20 natives of the town, were noticed on one of the side streets. Three American soldiers approached toward them. When in about 30 feet of them, one of the natives yelled out, 'Americans!' These three well-dressed natives were seized and taken toward headquarters. One of the natives was found to have no hat, after they had started. One of the soldiers went back and found his hat. In this hat was found some messages to Gen. Pilar, who was in Manila at the time. They were taken to headquarters and turned over to the commanding officer. Then the natives were forced to give Pilar's address. This information was telegraphed to Manila, where the native police were sent to arrest him, which they did. In the papers the police were given the honors and advanced a notch. The Thirty-fifth also stands among the first in capturing the most guns."

CHAS. H. BAKER.

He is "Looking for Something"—Has Deserted Principles.

The Oregonian of Oct. 11, contains an interview with Mr. C. H. Baker, of Lane county, one of the "39" who opposed the election of ex-senator Dulph. At that time Baker stood for bimetalism and good government, and was abused in a scandalous manner by Scott of the Oregonian. In fact he was known as "Bulldog Baker," the champion of silver. Later on he failed to get the nomination for senator in his county from the unionists and from that time he began to grow lukewarm, so his former Lane county friends say. Like others who are always "looking for something," Baker has finally deserted the principle for which he made so gallant a fight in 1893, and now takes his place at the tail end of the Mark Hanna procession. Scott now refers to him as a great and good man, when during the Dolph fight he was everything that was ignorant and mean.
