HON. JOHN KELLY.

A Sketch of the Old Pioneer's Life.

Hon. John Kelly, who died at his home in Eugene Saturday afternoon, and mention of which was made in Saturday's GUARD, was born in Dublin, Ireland, May 3, 1818, the son of a prominent manufacturer of woolen goods; his ancestors had been engaged for generations in the same industry, and he became very proficient in every department of his father's factory. In 1838 he made farewell to the parental roof, to his friends and native land, and crossed the sea to America. He lived at Hawksburg, Canada, for two years, as superintendent of a small factory. He moved to Swanton, Vermont, and in a like capacity resided there until 1842. In that year he pushed further westward, and located at Watford, Wisconsin, where he and George Hovey established the Watford Woolen Mills. At the end of five years he disposed of his interest, and went to St. Louis; in this city he enlisted for service in the Mexican war, joining the Third Regiment, Missouri Mounted Volunteers. His chief duty was scouting, and after a short period he was honorably discharged at Jefferson Barracks, Missouri, but was retained in the quartermaster's department. In the spring of 1849 he crossed the plains to Oregon with the regiment of mounted riflemen, arriving at Oregon City in October of the same year. His first business enterprise was taking a contract to furnish the regiment with beef, which he did until March, 1850. Then forming a partnership with three gentlemen, among them General Lane, he purchased a band of 300 cattle, and drove to Rogue River valley; here the general made a treaty with the Indians, and after this they continued their journey to Tehama county, California, where they passed the winter in mining on Olney creek. They drove the cattle to Scott valley in the spring of 1851, and established a ranch, but Mr. Kelly sold his interest and returned to Oregon. He purchased 200 head of cattle, took up a donation claim near Roseburg, and engaged in farming and stock-raising.

Mr. Kelly was married in La Fayette, Oregon, in 1853, to Miss Elizabeth Parker, a native of Indiana, and a daughter of P. O. Parker, who was a soldier in the Mexican war.

In 1861 he was appointed register of the United States land office, at Roseburg and filled the position until 1866, when he resigned. He performed the duties through a deputy, however, until 1868, when his successor was appointed. He removed to Springfield in 1866, and bought an interest in the Springfield Manufacturing Co; he disposed of his Roseburg property, and was elected superintendent of the company's works at Springfield, a position he filled until 1870, when the firm dissolved and the property divided. Mr. Kelly took as his share 240 acres, and engaged in farming until 1876. He was then appointed collector of customs, when he removed to Portland. He filled the office four years, at the end of which time he returned to Springfield, resuming the pursuit of agriculture. Under the administration of President Arthur he was appointed one of the three commissioners to accept 100 miles of the Northern Pacific railroad, and in 1890, was appointed superintendent of the census of Oregon.

Mr. and Mrs. Kelly are the parents of eight children: Mary L., wife of H. B. Miller; Theresa M., widow of L. Jackson; John P.; Marcella, wife of Albert H. Tanner; Abraham L.; George H.; Beale and Kate S. Mr. Kelly was a member of the I. O. O. F. and in both business and social circles had the respect of all who knew him.

The funeral was held this afternoon at the family residence, Ninth and Lawrence streets, under the auspices of Spencer Butte Lodge No. 9, I. O. O. F. Interment took place in the I. O. O. F. cemetery, the remains being followed by a large cortege.

DIED.—Wm. P. Nichols died last night at 12 o'clock in the Eugene hospital, from injuries received at Wending the other day while felling a tree, a limb of which broke off and struck him. He was a member of the Macabees, and the funeral will be conducted by that organization at the Christian church tomorrow morning at 10 o'clock. The remains will be interred in the I. O. O. F. cemetery.

WILL BUILD SOON.—Ed Hans has purchased a half of the east wall of S. M. Titus' brick building on Ninth street and will commence the erection of his one-story brick building shortly after the 4th of July. Gilfray & Whitaker, milliners, will move out of the building, which now occupies the lot, on the 5th of July and work will commence immediately thereafter.

ANOTHER DELIVERY WAGON.—On account of the increase of business the proprietors of the city delivery wagons have been compelled to place another wagon on the routes. This shows that Eugene is increasing in population.
